ORDER:

In the Government order first read above, Government have issued orders to the effect that the following courses be considered as equivalent to Indian Dairying Diploma awarded by Board of Dairy Education, Government of India for the purpose of Employment in Public Services and for promotion:-

- i. The Indian Dairy Diploma (Dairy Technology) offered by Allahabad Agricultural University and National Dairy Diploma (Dairy Technology) are equivalent qualification.
- ii. M.Sc Dairy Technology offered by Allahabad Agricultural Institute Deemed University and B.Tech (Food Processing Technology) offered by Tamil Nadu Veterinary and Animal Sciences University (TANUVAS) are highly equivalent qualification.

The Government had also directed that the following courses are not equivalent and hence, not suited for the post of Dairy Assistant:

- Indian Dairy Diploma (Dairy Husbandry) (Allahabad Agricultural Institute Deemed University)
- 2. Dairy Diploma in Dairy Management (Annamalai University)

- 3. Diploma in Livestock Products Technology (Annamalai University)
- 4. PG Diploma in Dairy Technology (Annamalai University)
- 2. Further, in respect of approving the equivalence of (i) M.Sc (Dairy Science) from the Manonmanian Sundaranar University, (ii) B.Tech (Food Processing and Engineering) from the Karunya Deemed University and (iii) M.Sc (Dairy Science) from the Gandhigram Deemed University to the Diploma in Dairying awarded by the Board of Dairy Education, Government of India, the 34th equivalence committee had recommended to obtain the opinion of Tamil Nadu Veterinary and Animal Sciences University and the Head of the Dairy Development Department and to circulate the decision among the members of the Committee.
- 3. Accordingly, the opinion of the Registrar, Tamil Nadu Veterinary and Animal Sciences University and Commissioner for Milk Production and Dairy Development has been obtained in the matter. The Registrar, Tamil Nadu Veterinary and Animal Sciences University has opined that M.Sc (Dairy Science) from the Manonmanian Sundaranar University, B.Tech (Food Processing and Engineering) from the Karunya Deemed University and M.Sc (Dairy Science) from the Gandhigram Deemed University are not suited for the post of Dairy Assistant in Dairy Development Department. This opinion of Tamil Nadu Veterinary and Animal Sciences University has been concurred by the Commissioner for Milk Production and Dairy Development.
- 4. In the letter second read above, the Government had communicated to the Tamil Nadu Public Service Commission the views of the Registrar, Tamil Nadu Veterinary and Animal Sciences University and Commissioner for Milk Production and Dairy Development and requested the Secretary, Tamil Nadu Public Service Commission to circulate the opinion of Tamil Nadu Veterinary and Animal Sciences University and Commissioner for Milk Production and Dairy Development among the Members of the Equivalence Committee and communicate the recommendation of the Equivalence Committee to Government.
- 5. In the reference third cited, the Secretary, Tamil Nadu Public Service Commission has stated that the subject was placed before the 53rd Equivalence Committee meeting and the Equivalence Committee has passed the following resolution:-

The Government after careful consideration, accept the recommendation of the 53rd Equivalence Committee and accordingly direct that the following courses awarded by the Universities mentioned therein as not equivalent to the Indian Dairying Diploma awarded by the Board of Dairy Education, Government of India for Employment in Public Services and for promotion and not suited for the post of Dairy Assistant in the Tamil Nadu Dairy Subordinate Service:-
 - 1. M.Sc., (Dairy Science) Manonmaniam Sundaranar University.
 - 2. B.Tech (Food Processing & Engineering) Karunya Deemed University.
