The following notification shall be published in the Tamil Nadu Government Gazette:

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Government Servants' Conduct Rules, 1973.

2 The amendments hereby made shall come into force on the 09th March '2010.

AMENDMENTS

In the said Rules,-

(1) in rule 6, in sub-rule(4),-

(i) in clause (a),-

(a) in the first proviso, for the expression "Rs.10,000/- (Rupees Ten thousand only)", the expression "his total monthly emoluments", shall be substituted;

(b) in the second proviso, for the expression "Rs.1,00,000/- (Rupees One lakh only)", the expression "Rs.3,00,000/- (Rupees Three lakhs only)" shall be substituted;

(ii) in clause (aa),-

- (a) for the expression "Rs.10,000/- (Rupees Ten thousand only)", the expression "his total monthly emoluments", shall be substituted;
- (b) in the proviso, for the expression "Rs.1,00,000/- (Rupees One lakh only)", the expression "Rs.3,00,000/- (Rupees Three lakhs only)" shall be substituted;

(2) in rule 7,-

- (a) in sub-rule (1), in clause (c), for the expression "Rs.10,000/- (Rupees Ten thousand only)" the expression "Rs.50,000 (Rupees Fifty thousand only)" shall be substituted;
- (b) in sub-rule (2), for the expression "exceeding Rs.15,000/- (Rupees fifteen thousand only) in value", the expression "exceeding Rs.80,000/- (Rupees Eighty thousand only) in value in respect of 'A' Group Officers, Rs.60,000/- (Rupees Sixty thousand only) in value in respect of 'B' Group Officers, Rs.40,000/- (Rupees Forty thousand only) in value in respect of 'C' Group Officers and Rs.20,000/- (Rupees Twenty thousand only) in value in respect of 'D' Group Officers" shall be substituted;
- (c) in sub-rule (3), in the Explanation thereunder for the expression "Rs.10,000/- (Rupees Ten thousand only)", the expression "Rs.50,000/- (Rupees Fifty thousand only)", shall be substituted;

(3) in rule 8,-

in sub-rule(1), in clause(a), in the fifth proviso, in item No.(iii), for the expression "Rs.2000/- (Rupees two thousand only)", the expression "Rs.25,000/- (Rupees Twenty five thousand only)", shall be substituted.
