

## **INSTRUCTION REGARDING POSTAL RECEIPT NUMBER**

Due to the upgradation of software in some post offices, a 21 digit postal receipt number is generated instead of 10 digit number. In this case, as per the Instruction of the postal Department candidates are instructed to enter the last 10 digits in the space provided to enter the postal receipt number while applying for the Departmental Examination through online. There will be no change if 10 digit postal receipt number is generated.
