- 4. He is also directed to bring all his original certificates (and photocopies of the same) for perusal / verification, at the time of counselling. He should submit a latest conduct certificate obtained on or after 01.03.2018 from a Government official of Group A or B cadre of his living area.
- 5. If employed, he should submit a "No Objection Certificate" from the appointing authority in the format prescribed in para 15(g) of the Commission's "Instructions to applicants". If punishment is imposed or charges are pending, copies of orders or charge memo. should also be produced.
- 6. In view of the fact that eligible candidates in the ratio of 1:3 have been summoned to the counselling, all of them are not assured of selection. He will be allotted the said post, subject to the availability of vacancy when he reaches his turn as per his ranking position.
- 7. His provisional admission to the counselling does not confer any right for selection to the said post.
- 8. If he does not appear for the counselling on the scheduled time, he will not be given any further chance to appear for the same and it will be construed that he is not willing to be considered for the supplemental selection to the said post.
- 9. The admission of the candidate to the counselling is purely provisional subject to the outcome of the Writ Petitions, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Madras High Court, relating to this recruitment.
