He should produce all the original documents along with self attested copies of two sets of photocopies in respect of all the claims made by him in the on-line application. Apart from that if he fails to produce any one or more of the following documents in original, at the time of Certificate Verification/ Oral Test he will not be admitted to the further process of selection under any circumstances and his application is liable to be rejected ;

- i. Evidence of date of birth (S.S.L.C. / H.S.C )
- ii. Evidence of educational qualification as specified in para 6(B) of the Commission's Notification dated 18.09.2018 for this post.
- iii. If the candidate does not possess the exact educational qualification prescribed in the notification, should produce evidence for equivalence of educational qualification in form of Government Orders issued prior to the date of Notification (i.e. before 18.09.2018) failing which their application will be summarily rejected.

- iv. (a) Consolidated Mark Sheets  
(b) Provisional Certificate / Degree Certificate.
- v. Evidence of Qualification in Tamil : S.S.L.C / P.U.C/H.S.C / Degree in the case of candidate who has passed the said examination(s) with Tamil as one of the language.
- vi. Persons claiming preference under PSTM: The candidate, who has claimed to have studied the prescribed educational qualification in Tamil medium, in his online application, should produce the evidence for having studied the said degree in Tamil Medium in the following format mentioning the medium of instruction as Tamil.

- vii. Community Certificate from the competent Revenue Authority as specified in para 15(f) of the Commission's instructions to Applicants.
- viii. Evidence for Religion (community certificate / TC)
- ix. Certificate of character and conduct obtained from the Head of Institution in which he/she last studied / studying.
- x. A conduct certificate obtained on or after 01.09.2018 from a government officer belonging to Group A or Group B duly mentioning the candidate's name, father's name, address and the period during which he is known to the government officer (Minimum period 2 years).
- xi. If employed, "No Objection Certificate" from the appointing authority in the format prescribed in para 15(g) of the Commission's Instructions to Applicants. If punishment is imposed or charges are pending, copy of orders or charge memo. and other connected records should also be produced.

- xii. In respect of Differently Abled candidates, fresh / proper Certificate of Disability obtained from the Medical Board as mentioned in the Commission's Notification, specifying the nature and degree of disability and also certifying that his/her disability would not render him/her incapable of efficiently discharging the duties attached for the above said post.
- xiii. An attested copy of all the above documents should be produced at the time of Certificate Verification.
- xiv. Three copies of recent passport size photographs.
- xv. A printout of this memorandum showing the date of Certificate Verification should be produced at the time of Certificate Verification/ Oral test.

Notes:

1. Mere inclusion of the Register Number of candidate will not imply that his candidature has been considered for certificate verification/ oral test.
2. If the candidate is found fully qualified with reference to the Commission's Notification for the said post after certificate verification / oral test, on production of all the required certificates, will be allowed to the further process. Consideration of the candidate for certificate verification/oral test should not be construed as a clearance for admission for further selection process.
3. The candidate who fail to produce the original documents of essential certificates mentioned above will not be admitted to the further selection process and they will not be given any further chance to appear for the certificate verification/ oral test.
4. The candidate will not be admitted to the certificate verification/oral test if he presents himself half-an-hour late after the scheduled time specified above.
5. The admission of the candidate to the Certificate Verification/oral test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court, if any relating to this recruitment.
6. The admission of the candidate is provisional subject to verification/acceptance of the documents in support of the claims made in his online application in respect of Age, Educational qualification, Communal Category, etc. Failure to produce the required certificates does not satisfy the eligibility criteria his provisional admission to certificate verification / oral test will be cancelled.
