A list of 171 candidates provisionally admitted to certificate verification for Oral Test for appointment by direct recruitment to the post of **MATERNAL AND CHILD HEALTH OFFICER IN THE TAMIL NADU PUBLIC HEALTH SERVICE 2014-15**, based on the results of the Written Examination conducted by the Commission on **20.09.2015 FN & AN** was published on 29.02.2016. 1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.

The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification for Oral Test based on the marks obtained by them in the Written Examination, Educational Qualification possessed by them and rule of reservation of appointments. The admission of candidates to Certificate Verification for Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, Differently Abled etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification for Oral Test will be cancelled and their application will be rejected.

The admission of the above candidates to the Certificate Verification for Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

Candidates who have been admitted provisionally to the Certificate Verification for Oral Test are hereby advised to attend the Certificate Verification for Oral Test with all the relevant documents in original, without fail. Failure to produce even anyone of the essential document will result in their non-admission to the Oral Test.
