**POSTS INCLUDED IN CCS-I EXAMINATION (GROUP I SERVICES)  
(Main Written Examination)**

**List- III**

Two lists containing the register numbers of candidates provisionally admitted to Certificate Verification for the **POSTS INCLUDED IN CCS-I EXAMINATION (GROUP I SERVICES)** were published in the Commission's website on 12.05.2017 and 20.06.2017 based on results of the written examination conducted by the Tamil Nadu Public Service Commission on 29.07.2016, 30.07.2016 and 31.07.2016. The Oral Test for the said posts was held from 07.08.2017 to 11.08.2017 for 148 candidates who were found eligible during Certificate Verification. All the 148 candidates who attended the Oral Test were called for counselling held on 18.08.2017. During the counselling, 19 candidates were absent and 73 candidates have been selected for appointment by direct recruitment to the said posts. One SC(W)(PSTM) in the post of Deputy Superintendent of Police could not be filled due to paucity of eligible candidates in the said category.

It has therefore been decided by the Commission to admit the candidates to the next phase of Certificate Verification in the ratio of 1:5. Hence, the candidates with the following register numbers are admitted provisionally to the Certificate Verification. The Certificate Verification will be held on **18.09.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. Individual intimation regarding the date and time of Certificate Verification will be sent to the candidates separately:-

**After completion of Certificate Verification, the list for provisional admission to Oral Test will be published.**

**Notes:**

1. **Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for next stage of selection.**
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification to find out their eligibility for admission to Oral Test based on the marks obtained by them in the Main Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Certificate Verification is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, Differently Abled Status, PSTM etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification will be cancelled and they will not be admitted to next stage of selection.
3. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP Nos. 20875/2016, 26205/2016, 26572/2016 and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
4. **Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to attend the Certificate Verification with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the next stage of selection.**
