A list of 57 candidates provisionally admitted to certificate verification for Oral Test for appointment by direct recruitment to the post of **Junior Inspector of Co-operative Societies in the Co-operative Department in the Tamil Nadu Co-operative Subordinate Service included in Combined Civil Services – III (Group-III A service)** based on results of the written examination conducted by the Tamil Nadu Public Service Commission on 03.08.2013 FN was published on 05.01.2016. In order to adhere to the ratio of 1:2/1:3 for admission to Oral Test, it has been decided by the Commission to substitute candidates in the place of absentees for certificate verification held on 27.01.2016 and also in the place of candidates whose eligibility status have been changed at the time of verification of original certificates.

As announced earlier in the list dated 05.01.2016, the Certificate Verification / Counselling for appointment by direct recruitment to the Non-Interview posts viz. Store Keeper, Grade-II in Industries and Commerce Department and Store-Keeper in Employment and Training (Training Wing) Department will be held after finalizing the selection to the post of Junior Inspector of Co-operative Societies in the Co-operative Department.

Notes:

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification for Oral Test based on the marks obtained by them in the Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Certificate Verification for Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Experience, Community etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to Oral Test.

The admission of the above candidates to the Certificate Verification for Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
4. Candidates who have been admitted provisionally to the Certificate Verification for Oral Test are hereby advised to attend the Certificate Verification for Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
