The candidates whose Register Numbers are mentioned below have been provisionally admitted to the Main written Examination for appointment by direct recruitment to the post of **Assistant Commissioner in the Tamil Nadu Hindu Religious and Charitable Endowments Administration Department in the Tamil Nadu Hindu Religious and Charitable Endowments Administration Service included in Group-I-B Services,2013-2014** based on the results of the Preliminary Examination conducted by the Commission on 03.09.2017 FN. 1. **Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for next stage of selection.**
2. The candidates whose Register numbers are found in the above list have been admitted **PROVISIONALLY** to the Main Written Examination based on the marks obtained by them in the Preliminary Examination and with reference to the rule of reservation of appointments in 1:20 ratio. However in each reservation group, all the candidates who have secured the same marks as that of the cut-off marks of their respective reservation groups have also been admitted to the Main Written Examination though the number of candidates exceed 1:20 ratio in the reservation group concerned with reference to Para 10 of the Commission's notification dated 01.06.2017.

The candidates whose Register numbers are found in the above list have been provisionally admitted to the Main Written Examination based on the particulars furnished by them in their online applications such as age, educational qualification, community, PSTM status, Differently Abled, Experience, Practising /Service certificate etc., subject to receipt, verification and acceptance of the copies of documents in support of the claims made in their online applications. If any of their claims are found to be false or incorrect, their candidature is liable for rejection at any point of time.
4. The candidates who have appeared for the Preliminary Examination and whose Register Numbers are not found in the above list have not been admitted to the Main Written Examination. Separate communication in this regard will not be sent to those candidates.
5. The admission of the above candidates to the Main Written Examination is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs if any and other cases pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court, if any, relating to this recruitment.
