Two lists of candidates admitted provisionally to certificate Verification for the post of **Hostel Superintendent cum Physical Training Officer in the Tamil Nadu Employment and Training Subordinate Service (2013-2014, 2014-2015, 2015-2016)** were published in the Commission's website on 27.09.2017 and 20.10.2017 based on the results of the written examination conducted by the Commission on 20.05.2017 FN & AN.

During the 1st & 2nd phases of Certificate Verification held on 09.10.2017 and 09.11.2017 respectively 16 candidates were absent and the applications of 12 candidates have been rejected.

After the 1st & 2nd phases of Certificate Verification, the candidates whose Register numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:2/1:3. The Oral Test will be held on **19.12.2017**, at the Office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.

6. The list of register numbers of candidates who were absent and whose applications were rejected after all the phases of Certificate Verification and who have not reached the zone of consideration for provisional admission to Oral Test have been mentioned in the Annexure to this list.
