Thiru.Jose Jerald Das.M.A. (Register No.010005031) (Rank No.(Civil):48) is hereby informed that he has been admitted provisionally to the counselling in connection with the supplemental selection to fill a vacancy in the post of Assistant Engineer (Civil), Water Resources Department in Public Works Department in the Tamil Nadu Engineering Service, 2012-2013 included in the Combined Engineering Services Examination, 2012-2013 and 2013-2014 that has arisen consequent to the cancellation of provisional selection of a candidate who had been selected supplementally for the post of Assistant Engineer (Civil), Water Resources Department, PWD during the II phase of counselling held on 20.01.2017.

2. He is, therefore, directed to present himself for the counselling at 10.30. A.M on 16.08.2017 at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai- 600 003 (Near Broadway Bus Terminus and Chennai Fort Railway Station).

3. The particulars of the vacancy are furnished below;

4. He is also directed to bring all his original certificates (and photocopies of the same) for perusal / verification, at the time of counselling. He should submit a latest conduct certificate obtained on or after 08.08.2017 from a Government official of Group A or B of his living area.

5. If employed, he should submit a "No Objection Certificate" from the appointing authority in the format prescribed in para 15(g) of the Commission's "Instructions to applicants". If punishment is imposed or charges are pending, copies of orders or charge memo. should also be produced.

6. In view of the fact that eligible candidates in the ratio of 1:3 have been summoned to the counselling, all of them are not assured of selection. He will be allotted the post, subject to the availability of vacancy when he reaches his turn as per his ranking position.

7. His provisional admission to the counselling does not confer any right for selection to the said post.

8. If he does not appear for the counselling on the scheduled time, he will not be given any further chance to appear for the same and it will be construed that he is not willing to be considered for the supplemental selection to the said post.

9. The admission of the candidate to the counselling is purely provisional subject to the outcome of the Writ Petitions, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Madras High Court, relating to this recruitment.

10. He is further informed that the details of Register Nos. of the candidates admitted provisionally to the counselling and their ranking position are furnished in the list enclosed.
