The admission of candidates to Certificate

Verification is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, Experience etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification will be cancelled and they will not be admitted to Oral Test.
