

## ASSISTANT JAILOR IN PRISON DEPARTMENT IN THE TAMIL NADU JAIL SUBORDINATE SERVICE (1996-2010)

Four lists of candidates admitted provisionally to Certificate Verification for the post of **ASSISTANT JAILOR IN PRISON DEPARTMENT IN THE TAMIL NADU JAIL SUBORDINATE SERVICE (1996-2010)** were published in the Commission's website on 26.04.2017, 13.07.2017, 23.08.2017 and 03.10.2017 based on the results of the written examination conducted by the Commission on 24.07.2016 FN & AN.

During the 1<sup>st</sup> Phase of Certificate Verification held on 01.06.2017 & 02.06.2017, 41 candidates were absent, the applications of 7 candidates have been rejected and eligibility status of 1 candidate has changed. Hence, 50 candidates were admitted provisionally for the 2<sup>nd</sup> phase of Certificate Verification. During the 2<sup>nd</sup> Phase of Certificate Verification held on 26.07.2017, 15 candidates were absent. It had therefore been decided by the Commission to admit the candidates to the 3<sup>rd</sup> phase of Certificate Verification at the ratio of 1:3. During the 3<sup>rd</sup> Phase of Certificate Verification held on 06.09.2017, 12 candidates were absent, the application of 1 candidate had been rejected and eligibility status of 4 candidates have changed. It had therefore again been decided by the Commission to admit the candidates to the 4th phase of Certificate Verification at the ratio of 1:3. During the 4<sup>th</sup> Phase of Certificate Verification held on 11.10.2017, 11 candidates were absent, the applications of 5 candidates have been rejected and eligibility status of 2 candidates have changed.

After the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> Phases of Certificate Verification, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:2/1:3. The Oral Test will be held on 15.11.2017 and 16.11.2017, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai - 600 003. The candidates should come to office of the Tamil Nadu Public Service Commission with all original certificates in support of the claims made in their online applications. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP No. 15981 of 2016 and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment
- 5. Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to attend the Certificate Verification with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the next stage of selection.
- 6. The list of register numbers of candidates who were absent, whose application were rejected, who were found ineligible after 4<sup>th</sup> phase of Certificate Verification and who have not reached the zone of consideration for provisional admission to Oral Test have been mentioned in the Annexure to this list.
