Nos.445,501 & 509 of 2020 and Contempt petition No.437 of 2021, the list of 33 candidates admitted provisionally to Oral Test held on 05.08.2019 published on the Commission's website on 15.07.2019 and subsequent selection are hereby cancelled.

5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents without fail. Failure to produce even any one of the essential documents will result in their non-admission to Oral Test.
