## STATISTICAL INSPECTOR IN THE TAMIL NADU ANIMAL HUSBANDRY SUBORDINATE SERVICE LIST-OT

Two lists of candidates provisionally admitted to Certificate Verification for the post of **Statistical Inspector in the Tamil Nadu Animal Husbandry Subordinate Service** was published in the Commission's website on 30.01.2019 & 13.02.2019 based on the results of the written examination conducted by the Commission on 23.12.2018 FN & AN.

The admission of the above candidates to the oral test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
- 5. Candidates who have been admitted provisionally to the oral test are hereby advised to attend the oral test with all the relevant documents in original, without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
- 6. The list of register numbers of candidates who were admitted to Certificate Verification and who have not been considered for provisional admission to Oral Test and the reasons therefor have been mentioned in the Annexure to this list.
