If they do not produce the required certificates or if they do not satisfy the eligibility criteria their provisional admission to Oral Test will be cancelled. Mere inclusion of candidates in this list will not confer any right on the part of candidates to

claim for participation in Oral Test. The Certificate Verification will be held on 20.10.2015. Individual intimation regarding the date and time of the Certificate Verification/Oral Test will be sent to the candidates separately.

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.

The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Computer Based Test, Educational Qualification possessed by them and with reference to rule of reservation of appointments. The admission of candidates to Oral Test in para 3 above is provisional subject to verification and acceptance of their claim in their online applications towards Age, Educational Qualification etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to Oral Test.

The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs (if any) and any other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court relating to this recruitment.
4. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
