**BLOCK HEALTH STATISTICIAN IN THE TAMIL NADU  
MEDICAL SUBORDINATE SERVICE (2002-2006)**

A list of Register Numbers of candidates provisionally admitted to Oral Test for appointment by direct recruitment to the post of **BLOCK HEALTH STATISTICIAN in the Tamil Nadu Medical Subordinate Service 2002 – 2006**, was published in the Commission's website on 01.08.2014, based on the results of written examination conducted by the Commission on 26.02.2011AN.

2. Two additional lists of candidates provisionally admitted to Certificate Verification were published on 12.08.2015 and 29.09.2015. During Certificate Verification, few candidates have absented themselves and applications of few candidates have been subsequently rejected and the eligibility status of some candidates has changed.

3. Apart from the 39 candidates who have already appeared for Oral Test, the following is the list of register numbers of candidates who are now eligible for admission to oral test which will be held on **02.02.2016** at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai - 600003. The admission of the candidates with the following register number to Certificate Verification / Oral Test is purely provisional subject to verification/acceptance of his/her documents; Educational qualification/ Equivalence of qualification etc. Only after verification, his/her eligibility will become final for admission to Oral Test (interview). If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria his/her provisional admission to Oral Test will be cancelled. Mere inclusion of register number in this list will not confer any right on the part of candidate to claim for participation in Oral Test. The Certificate Verification will be held on 02.02.2016 FN. Individual intimation regarding the date and time of the Certificate Verification/ Oral Test will be sent to the candidate separately:-

Notes :

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidate whose register number is mentioned in para 4 above to Oral Test is provisional subject to verification and acceptance of the claim in his/her online application towards Age, Educational Qualification etc, through original documents. If any of his/her claims are found to be false or incorrect, his/her provisional admission to Oral Test will be cancelled and his/her application will be rejected.
3. The admission of the above candidates to the Oral Test is purely provisional, subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
