Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

The candidates with the following Register Numbers are admitted to Physical Certificate Verification and Counselling and his/her admission to Physical Certificate Verification and Counselling is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Educational Qualification, etc. Only after verification of the claims with the original

3. The candidates whose register numbers are placed under the heading "LIST-I" above are eligible for all the posts including posts for which specific educational qualification has been prescribed, based on the marks obtained by them in the main written examination, required qualification possessed by them, rule of

reservation of appointments and other conditions stipulated in the notification.

4. The candidates whose register numbers placed under the heading "LIST-II" above are eligible only to the following posts prescribing specific educational qualification since they have been specially selected for the said post based on their educational qualification claim.

5. The candidates who had appeared for Main written examination on 25.02.2023 F.N and A.N. and whose Register Numbers are not found in the above list have not been admitted to the Physical Certificate Verification and Counselling for this recruitment.

6. After verification of original certificates, the eligible candidates alone will be admitted for counselling to be held on the same day itself.

7. The candidates can download their Memorandum for Admission to Physical Certificate Verification and Counselling from the Commission's Website and should attend the Physical Certificate Verification and counselling with all the relevant documents in original on the prescribed date and time without fail. Candidates who have failed to attend Physical Certificate Verification and Counselling on the scheduled date and time will not be considered for the next stage of selection.

8. Candidates who have been admitted for Physical Certificate Verification and Counselling are hereby advised to watch the Commission's website everyday regarding availability of vacancies which will be hosted in the Commission's website at the end of Counselling every day. The provisional admission of candidates to Physical Certificate Verification and Counselling does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.

9. The admission of above candidates for Physical Certificate Verification and Counselling is purely provisional subject to the
