



POST OF EXECUTIVE OFFICER, GRADE-IV INCLUDED IN GROUP-VIII SERVICES IN TAMIL NADU HINDU RELIGIOUS AND CHARITABLE ENDOWMENTS SUBORDINATE SERVICE

The candidates whose register numbers are mentioned below have been provisionally admitted to Physical Certificate Verification [**Phase-III**] for the post of **EXECUTIVE OFFICER, GRADE-IV INCLUDED IN GROUP-VIII SERVICES IN TAMIL NADU HINDU RELIGIOUS AND CHARITABLE ENDOWMENTS SUBORDINATE SERVICE** based on the marks and rank position hosted on the Commission's website on 14.07.2023, for which the written examination was conducted by the Commission on 11.09.2022 F.N. & A.N. The Physical Certificate Verification (Phase -III) for the said post will be held on **22.07.2024 F.N.** The Physical Certificate Verification will be held at the Office of the TNPSC, No. 3, TNPSC Road, Chennai - 600 003.

Individual intimation regarding the date and time of Physical Certificate Verification will be informed through Commission's website, SMS and e-mail only. Individual intimation will not be sent to the candidates by post.

The candidates with the following register numbers have been admitted to Direct Physical Certificate Verification and his admission to Certificate Verification is purely provisional subject to verification and acceptance of the documents in support of the claims made in his online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Educational Qualification, Experience, etc. Only after verification of the claims with the original certificates, his eligibility will become final for admission to further selection process. If he does not produce the required certificates or if he does not satisfy the eligibility criteria, his online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled.

1. Mere inclusion of the register numbers of candidates will not imply that his/her candidature has been fully considered for Physical Certificate Verification.
2. The candidates whose register numbers are mentioned in the above list have been admitted provisionally to the Physical Certificate Verification based on the particulars furnished by them in their online application, overall rank obtained by them in the written examination and with reference to the rule of reservation of appointments and number of vacancies.
3. The candidates who had appeared for written examination on 11.09.2022 FN & AN to the post of Executive Officer, Grade-IV Included in Group-VIII Services in

Tamil Nadu Hindu Religious and Charitable Endowments Subordinate Service and whose register numbers are not found in the above list have not been admitted to the Physical Certificate Verification for the said post.

4. After verification of original certificates, the eligible candidates alone will be considered for further selection process.
5. The candidates can download their Memorandum for Admission to second phase Physical Certificate Verification from the Commission's Website and should attend the Physical Certificate Verification with all the relevant documents in original on the prescribed date and time without fail. Candidates who have failed to attend Physical Certificate Verification on the scheduled date and time will not be considered for the next stage of selection.
6. The provisional admission of the candidates to Physical Certificate Verification does not confer any right for selection and their selection will also be subject to availability of vacancies in their respective reservation categories and they are not assured of their selection.
7. The admission of above candidates for Physical Certificate Verification is purely provisional subject to final orders to be passed in W.A. (MD) No.181 of 2023 and CMP (MD) 2247 of 2023 pending before the Hon'ble High Court and other cases, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court relating to this recruitment.
