1. After Onscreen Certificate Verification, the list of eligible candidates for Oral Test will be published subsequently in the ratio of 1:3.
2. **Mere inclusion of the register number of the candidates does not imply that his / her candidature has been fully considered for next stage of selection.**
3. The candidates whose register number are found in the above list have been provisionally admitted to the Onscreen Certificate Verification based on the marks obtained by them in the written examination (Descriptive Type) and with reference to the rule of reservation of appointments.
4. The admission of candidates to the Onscreen Certificate Verification is provisional subject to verification and acceptance of the claims as made in their respective online application with regard to Age, Educational Qualification, Technical Qualification, Communal category, Gender, Differently Abled category etc., through original documents. If any of the candidate claims is found to be false or incorrect, their online applications will be rejected and their provisional admission to the Onscreen Certificate Verification will be cancelled and they will not be admitted to the next stage of selection.
5. The admission of the above candidates to the Onscreen Certificate Verification is purely provisional subject to the final orders to be passed in W.A. (MD) No.181 of 2023 and CMP (MD) No.2247 of 2023 and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
