After Onscreen Certificate Verification-Cum-Physical Fitness Test for the post of College Director of Physical Education and Sports in Government Law Colleges and Onscreen Certificate Verification for other posts, the list of eligible candidates for Oral Test will be published in the ratio of 1:2/1:3.
- 2. Mere inclusion of the register number of a candidate will not imply that his/her candidature has been fully considered for next stage of selection.
- 3. The candidates whose register numbers are found in the above list have been admitted provisionally to the Onscreen Certificate Verification based on the marks obtained by them in the

examination (Computer Based Test), rule of reservation of appointments and other conditions stipulated in the Notification for the said recruitment.

- 4. The admission of candidates to Onscreen Certificate Verification is provisional subject to verification and acceptance of the claims as made in their online application towards Age, Educational Qualification, Communal category, Differently Abled category, PSTM Status, Experience, etc., through original documents. If any of their claims is found to be false or incorrect, their online application will be rejected, their provisional admission to Onscreen Certificate Verification will be cancelled and they will not be admitted to the next stage of selection.
