Candidates are directed to watch the Commission's website, 'X' account, Telegram Channel and WhatsApp Channel periodically for all updates and intimations. The Commission shall not be responsible if the communication does not reach the applicant due to incorrect / invalid e-mail ID /mobile number and failure / delay in delivery of SMS / e-mail to the candidates due to any reason including technical issues. Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

Note:

- 1. Mere inclusion of the register number of a candidate in this list will not imply that his / her candidature has been fully considered for the Main Written Examination.**
2. The candidates whose register number is found in the above list have been admitted provisionally to the Main Written Examination in the ratio of 1:10 based on the marks obtained by them in the Preliminary Examination, rule of reservation of

appointments and other conditions stipulated in the said Notification. Further, in each reservation group, all the candidates who have secured the same marks as that of the cut-off marks of their respective reservation group, have also been admitted provisionally to the Main Written Examination though the number of candidates exceed 1:10 ratio in the reservation group concerned with reference to para 5.4 of the Commission's Notification for this recruitment.

3. The admission of candidates to the Main Written Examination is provisional subject to verification and acceptance of the claims as made in their online application and uploaded documents with regard to Age, Educational Qualification, Experience, Communal category, Differently Abled category, Adequate knowledge in Tamil as per said notification, PSTM , Enrolment certificate issued by the Bar Council, Practice Certificate for a temporary Assistant Public Prosecutor, Grade-II, Fee payment etc.
4. Any discrepancy between the details as given in the online application and the documents submitted shall result in the summary rejection of candidature after due process and they will not be admitted to the Main Written Examination and to the further stages of selection. No supplemental list will be published in the place of rejected candidates (or) candidates who have failed to upload documents for verification when called for.
5. The candidates who have appeared for the Preliminary Examination and whose register number is not found in the above list, have not been admitted to the Main Written Examination. Individual communication in this regard will not be sent to those candidates.

6. The admission of the above candidates to the Main Written Examination is purely provisional subject to the decision of the Commission and subject to the outcome of the cases, if any, pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court relating to this recruitment.
