A list of 164 candidates provisionally admitted to Certificate Verification for Oral Test for appointment by direct recruitment to the posts included in Group I services, 2012-2014 was published in the Commission's website on 17.06.2016 based on the results of the Main written examination conducted by the Commission on 05.06.2015, 06.06.2015 & 07.06.2015.

In order to adhere to the ratio of 1:2/1:3 for admission to Certificate Verification for Oral Test, it has been decided by the Commission to substitute candidates in the place of absentees for Certificate verification held on 04.07.2016 & 05.07.2016. Hence, apart from the 160 candidates who had already attended the Certificate verification, the candidates with the following register numbers are hereby admitted provisionally to the certificate verification for the said post.

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.

The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification for Oral Test based on the marks obtained by them in the Main Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to the Certificate Verification for Oral Test is provisional subject to verification and acceptance of their claim in their online applications towards Age, Educational Qualification, Community etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to the Certificate Verification for Oral Test will be cancelled and they will not be admitted to Oral Test.

The admission of the above candidates to the Certificate Verification for Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs (if any) and any other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court relating to this recruitment.
4. **Candidates who have been admitted provisionally to the Certificate Verification for Oral Test are hereby advised to attend the Certificate Verification for Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Certificate Verification for Oral Test.**
