Due to the poor turnout of candidates to CV, candidates are not available in respect of certain categories.

They are directed to appear in person with all original certificates mentioned in their online applications in support of their claim.

Candidates who have been admitted to the Certificate Verification are hereby advised to attend the Certificate Verification on the designated date and time with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
