(2nd PHASE)**

A list of 49 candidates provisionally admitted to Oral Test for appointment by direct recruitment to the post of **EXECUTIVE OFFICER, GRADE-IV IN TAMIL NADU HINDU RELIGIOUS AND CHARITABLE ENDOWMENTS SUBORDINATE SERVICE** included in Group VIII Services, 2013-2014 was published in the Commission's website on 12.06.2015. From the said list, 26 candidates had not attended the certificate verification / Oral Test and the provisional admission of 1 candidate to oral test has been cancelled due to wrong claim. Due to poor turn out of candidates, it has been decided by the Commission to admit the candidates for Certificate Verification at the ratio of 1:4. Accordingly for 23 vacancies, the number of candidates to be admitted is 92.

Hence, apart from the 22 candidates who had already attended the Certificate verification and Oral Test, the candidates with the following register numbers are hereby admitted provisionally to the certificate verification for the said post.

The certificate verification will be held on 06.07.2015 at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. Individual intimation regarding the date and time of the Certificate verification will be sent to the candidates separately.

From among those who have been called for CV now, candidates will be admitted to Oral Test in the ratio of 1:2 / 1:3 only based on merit and following the rule of reservation of appointments. List of candidates eligible for Oral Test will be published in the notice board at the Tamil Nadu Public Service Commission office and Commissions website on 06.07.2015 Evening/ Night. The oral test will be held on 08.07.2015. Candidates must come prepared for the same.

1. Mere inclusion of the Register Numbers of candidates in the above list will not imply that his/her candidature has been fully considered for Oral Test.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate verification based on the marks obtained by them in the Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Certificate Verification is provisional subject to verification and acceptance of their claim in their online applications towards Age, Educational Qualification, Ex-servicemen, Destitute Widow, Community and PSTM etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission will be cancelled and they will not be admitted to Oral Test.
3. The Candidates who have appeared for the Written Examination and whose register numbers are not found in the above list have not been admitted to the Certificate Verification.
4. The admission of the above candidates to the Certificate Verification is purely provisional and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs (if any) and any other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court relating to this recruitment.
5. Candidates who have been admitted to the Certificate Verification are hereby advised to attend the Certificate Verification on the designated date and time with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
