- 4. Intimation regarding Physical Certificate Verification and Counselling will be informed through the Commission's website, SMS and e-mail through registered mobile number and email ID only. No individual communication shall be sent to the candidates by post.
- 5. The candidates can download their Memorandum for Admission to Physical Certificate Verification and Counselling from the Commission's Website and should attend the Physical Certificate Verification and Counselling with all the relevant documents in original on the prescribed date and time without fail. Candidates who have failed to attend Physical Certificate Verification and Counselling on the scheduled

date and time will not be considered for the next stage of selection.

- 6. The admission to Physical Certificate Verification and Counselling is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Destitute Widow, Differently Abled Person, Ex-Servicemen, Educational Qualification, Technical Qualification, etc., Only after verification of the claims with the original certificates, his/her eligibility will be decided for admission to Counselling. After verification of original certificates, the eligible candidates alone will be admitted for counselling to be held on the same day itself. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification and Counselling will be cancelled.
- 7. Mere inclusion of the Register Numbers of candidates in the above list will not imply that his/her candidature has been fully considered for selection. The provisional admission of candidates to Physical Certificate Verification and Counselling does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.
- 8. The post, Department / Board / Corporation / Authority and the unit once selected by the candidate will not be changed under any circumstances. Candidates who have participated and once selected a post in the counselling will not be allowed to participate in counselling for other posts.
- 9. Candidates who have been admitted for Physical Certificate Verification and Counselling are hereby advised to watch the Commission's website everyday regarding availability of vacancies which

will be hosted in the Commission's website at the end of Counselling

every day.

10. The candidates are provisionally admitted to Physical Certificate

Verification and Counselling for the post of Junior Assistant with

Technical/Special qualification in the ratio of 1:5 for General Turn

category and 1:2 for all reservation categories. For the post of

Receptionist Cum Telephone Operator in Tamil Nadu Corporation for

Development of Women Ltd., the candidates are provisionally admitted to

direct Physical Certificate Verification and Counselling in the ratio of 1:10

for General Turn category.
