5. Intimation regarding Physical Certificate Verification and Counselling (Phase II) will be informed through the Commission's website, SMS and e-mail through registered mobile number and email ID only. No individual communication shall be sent to the candidates by post.

6. The candidates can download their Memorandum for Admission to Physical Certificate Verification and Counselling (Phase II) from the Commission's Website and should attend the Physical Certificate Verification

and Counselling (Phase II) with all the relevant documents in original on the prescribed date and time without fail. Candidates who have failed to attend Physical Certificate Verification and Counselling(Phase II) on the scheduled date and time will not be considered for the next stage of selection.

7. The admission to Physical Certificate Verification and Counselling (Phase II) is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Destitute Widow, Differently Abled Person, Ex-Servicemen, Educational Qualification, Technical Qualification, etc., Only after verification of the claims with the original certificates, his/her eligibility will be decided for admission to Counselling. After verification of original certificates, the eligible candidates alone will be admitted for counselling to be held on the same day itself. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification and Counselling (Phase II) will be cancelled.

8. Mere inclusion of the Register Numbers of candidates in the above list will not imply that his/her candidature has been fully considered for selection. The provisional admission of candidates to Physical Certificate Verification and Counselling (Phase II) does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.

9. The post, Department / Board / Corporation / Authority and the unit once selected by the candidate will not be changed under any circumstances. Candidates who have participated and once selected a post

in the counselling will not be allowed to participate in counselling for other posts.

10. Candidates who have been admitted for Physical Certificate Verification and Counselling (Phase II) are hereby advised to watch the Commission's website regarding availability of vacancies which will be hosted in the Commission's website at the end of Counselling.

11. The candidates are provisionally admitted to Physical Certificate Verification and Counselling (Phase II) for the post of Junior Assistant (including Village Administrative Officer and other posts) in the ratio of 1:3 for all categories.

12. The admission of the above candidates to the Physical Certificate Verification and Counselling (Phase II) is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
