The candidates whose register numbers are mentioned below have been provisionally admitted to Physical Certificate Verification (PCV) – Phase II for the post mentioned above based on the marks and rank position hosted in the Commission's website on 25.10.2024, for which the written examination was conducted by the Commission on 06.01.2024 FN & AN. The Physical Certificate Verification for 09 candidates whose resister numbers are mentioned below will be held on 06.12.2024 at the office of the TNPSC, No. 3, TNPSC Road, Chennai – 3.

2. Among the 9 candidates, Onscreen Certificate Verification for the Register number 0301001094 has already been completed and provisionally admitted for Physical Certificate Verification. The Onscreen Certificate Verification (OCV) for remaining candidates has not been completed and admitted provisionally for **Direct Physical Certificate Verification** subject to production of required documents in Prescribed Format. If he/she does not produce the required documents or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled. 3. Individual intimation regarding the PCV will be informed through Commission's website, SMS and e-mail only. No individual intimation will be sent to the candidates by post. The admission to Physical Certificate Verification is purely provisional subjectto verification and acceptance of the original documents in support of allthe claims made in the online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Educational Qualification, Experience, etc. Only after verification of all the claims with the original certificates, the eligibility of such candidates will become final. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission will be cancelled.

Notes:

- 1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for next stage of selection.
- 2. The candidates whose Register Numbers are mentioned in theList have been admitted provisionally to Physical Certificate Verification based on the particulars furnished by them in their online application, mark and overall rank obtained by them in the written examination and with reference to the rule of reservation of appointments and number of vacancies.
- 3. The candidates who had appeared for written examination on 06.01.2024 FN & AN and their Register Numbers are not found in the above list have not been admitted to the Physical Certificate Verification for the said post.
- 4. After verification of original documents, the eligible candidates alone will be considered for further selection process.
- 5. The candidates can download their Memorandum for Admission from the Commission's Website and should attend the Physical Certificate Verification with all the relevant documents in original on the prescribed date and time without fail.

- 6. Candidates who have failed to attend Physical Certificate Verification on the scheduled date and time will not be considered for the next stage of selection.
- 7. The provisional admission of the candidates to Physical Certificate Verification does not confer any right for selection and their selection will also be subject to vacancies in their respective reservation categories as per rule of reservation.
- 8. The admission of above candidates for PCV is purely provisional subject to the outcome of writ petitions, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court relating to this recruitment.
