



**POSTS OTHER THAN JUNIOR DRAUGHTING OFFICER, HIGHWAYS  
DEPARTMENT INCLUDED IN COMBINED ENGINEERING SUBORDINATE  
SERVICES EXAMINATION  
(NOTIFICATION NO.05/2023)**

The candidates whose register numbers are mentioned below have been provisionally admitted to Physical Certificate Verification and Counselling [**Phase-II**] for the posts other than Junior Draughting Officer, Highways Department included in Combined Engineering Subordinate Services Examination based on the marks and rank position hosted on the Commission's website on 19.09.2023, for which the written examination was conducted by the Commission on 27.05.2023 F.N. and A.N. The Physical Certificate Verification and Counselling (Phase-II) for the said posts will be held on **14.05.2024** at the Office of the TNPSC, No. 3, TNPSC Road, Chennai - 600 003.

The candidates with the following register numbers have been admitted to Physical Certificate Verification and Counselling (Phase-II) and his/her admission to Certificate Verification is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Educational Qualification, Experience, etc. Only after verification of the claims with the original certificates, his/her eligibility will become final for admission to further selection process. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification and Counselling (Phase-II) will be cancelled.

The candidates who had appeared for written examination on 27.05.2023 F.N. and A.N for the posts included in Combined Engineering Subordinate Services Examination and whose register numbers are not found in the above list have not been admitted to the Physical Certificate Verification and Counselling for the said posts.
4. After verification of original certificates, the eligible candidates alone are admitted to Counselling to be held on the same day itself.

The candidates can download their Memorandum for Admission to Physical Certificate Verification and Counselling (Phase-II) from the Commission's Website and should attend the same with all the relevant documents in original on the prescribed date and time without fail. Candidates who have failed to attend Physical Certificate Verification and Counselling on the scheduled date and time will not be considered for the next stage of selection.
6. The provisional admission of the candidates to Physical Certificate Verification and Counselling does not confer any right for selection and their selection will also be subject to availability of vacancies in their respective reservation categories and they are not assured of their selection.
7. The admission of above candidates for Physical Certificate Verification and Counselling is purely provisional subject to final orders to be passed in W.A. (MD) No.181 of 2023 and CMP (MD) 2247 of 2023 pending before the Hon'ble High Court and other cases, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court relating to this recruitment.
