4. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Onscreen Certificate Verification based on their rank position, rule of reservation of appointments, number of vacancies and other conditions stipulated in the Notification.

The admission of the above candidates to Onscreen Certificate Verification is purely provisional, subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Date of Birth, Gender, Communal Category, Persons Studied in Tamil Medium, Destitute Widow, Differently Abled Person, Ex-Servicemen, Educational / Technical Qualification, Physical Measurement, etc.,

6. The candidates who had appeared for written examination on 12.07.2025 F.N and whose Register Numbers are not found in the above list have not been admitted to the Onscreen Certificate Verification for this recruitment.

7. The admission of the above candidates for Onscreen Certificate Verification is purely provisional subject to the decision of the Hon'ble Commission and final orders to be passed in the cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court of Judicature at Madras /Madurai Bench of Madras High Court.

8. Mere inclusion of the Register Numbers of candidates in the above list will not imply that his/her candidature has been fully considered for selection. The provisional admission of candidates to Onscreen Certificate Verification does not confer any right for selection and their selection will also be, subject to the availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.
