The list of Register Number of **1,236** candidates who have been provisionally admitted to Onscreen Certificate Verification for posts included in Combined Technical Services Examination (Interview Posts), in the ratio of 1:3/1:4 (posts not requiring experience) and 1:10 (posts requiring experience except for the post of Assistant Planner) based on the results of the Examination (Computer Based Test) conducted by the Commission from 20.07.2025 to 22.07.2025, was published on the Commission's website on 05.11.2025.

Based on the outcome of the Onscreen Certificate Verification (Phase-I), the application of certain candidates has been rejected in the said recruitment, as they do not satisfy the eligibility conditions as per the said notification. 1. After completion of Onscreen Certificate Verification (Phase-II), the list of eligible candidates for Physical Certificate Verification and Interview will be published in the ratio of 1:2/1:3.
2. Mere inclusion of the register number of a candidate in the list above, will not imply that his/her candidature has been fully considered for next stage of selection.
3. The candidates whose register number is found in the above list have been admitted provisionally to the Onscreen

Certificate Verification (Phase-II) based on the marks obtained by them in the examination (Computer Based Test), rule of reservation of appointments and other conditions stipulated in the Notification for the said recruitment.

4. The admission of candidates to Onscreen Certificate Verification (Phase-II) is provisional subject to verification and acceptance of the claims as made in their online application viz., Educational Qualification, Technical Qualification (Typewriting and Shorthand), PSTM, Date of Birth, Gender, Communal Category, Experience, Knowledge in Tamil, Registration in Veterinary Council and Special Category (viz., Differently Abled, Ex-Servicemen, Destitute Widow) etc. through original documents. If any of their claims are found to be false or incorrect, their online application will be rejected, their provisional admission to Onscreen Certificate Verification will be cancelled and they will not be admitted to the next stage of selection.

The admission of candidates to the Onscreen Certificate Verification (Phase-II) is purely provisional subject to the final orders to be passed in W.P.Nos.18477, 19586, 26033, 26618, 20154 and 26858 of 2025, 2219 of 2026, W.A(MD) No.181 of 2023 & CMP (MD) No. 2247 of 2023 and other cases, relating to this recruitment, if any, under subjudice in the Hon'ble High Court of Judicature at Madras/Madurai Bench of Madras High Court."
