In obedience of the orders of Hon'ble High Court of Madras, dated 02.08.2023 and 17.08.2023 in the Writ Petition Nos.5872/2022 & 3836/2023 respectively, the register number of candidates mentioned below have been provisionally admitted to direct Physical Certificate Verification-cum-Oral Test (Phase-II) based on the marks obtained by the candidates in the Written Examination which was held on 23.06.2019 FN & AN and other conditions stipulated in the notification for the post of Drugs Inspector in the Tamil Nadu Medical Service. Individual communication regarding the date and time of the said Physical Certificate Verification-cum-Oral Test (Phase-II) will not be sent to the candidates by post.

(\*) - the candidate has been admitted provisionally to direct Physical Certificate Verification-cum-Oral Test (Phase-II) subject to outcome of W.A.No.1767/2023.

**NOTE:**

1. **Mere inclusion of the register number of candidates in the above list will not imply their candidature has been fully considered for next stage of selection in the said recruitment.**
2. The candidates whose register number is found in the above list has been provisionally admitted to the direct Physical Certificate Verification-cum-Oral Test (Phase-II) based on the marks obtained by them in the Written Examination and with reference to the rule of reservation of appointments.
3. The admission of candidates to direct Physical Certificate Verification-cum-Oral Test (Phase-II) is provisional subject to verification and acceptance of the claims as made in their respective online application with regard to Age, Educational Qualification, Community, Differently Abled category etc., through original documents. If any of the claim of the candidates is found to be false or incorrect, their provisional admission to the said Oral Test (Phase-II) will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for the Written Examination and whose register number is not found in the above list have not been admitted to the said Physical Certificate Verification-cum-Oral Test (Phase-II).

5. The admission of the above candidates to the direct Physical Certificate Verification-cum-Oral Test (Phase-II) is purely provisional subject to the decision of the Commission and subject to the final orders to be passed in W.A.No.1767/2023 and other Writ Petitions relating to this recruitment pending if any, on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.

Candidates who have been provisionally admitted to the direct Physical Certificate Verification-cum-Oral Test (Phase-II) are hereby advised to attend the same with all the relevant documents in original without fail. Failure to produce even any one of the essential documents will result in their non admission to the next stage of selection.
