The list of Register Number of candidates who have been provisionally admitted to Oral Test (Phase-II) in the ratio of 1:3 for the post of Manager (Veterinary) in the Tamil Nadu Co-operative Milk Producers' Federation Limited based on the results of the examination conducted by the Commission on 09.12.2023 AN and 10.12.2023 FN, had been published on the Commission's website on 06.08.2024.

After completion of Oral Test (Phase-II), eligible candidates for a total of 4 vacancies in the post of Manager (Veterinary), Tamil Nadu Co-operative Milk Producers' Federation Limited, are not available for selection.

Individual communication regarding the date and time of the said Physical Certificate Verification-cum-Oral Test (Phase-III) will not be sent to the candidates by post.

2. The candidates whose register number is found in the above list, have been admitted provisionally to the Physical Certificate Verification-cum-Oral Test (Phase-III) based on the marks obtained by them in the

examination, rule of reservation of appointments and other conditions stipulated in the notification for the said recruitment.

The admission of candidates to Physical Certificate Verification-cum-Oral Test (Phase-III) is provisional subject to verification and acceptance of the claims as made in their online application towards Age, Gender, Educational Qualification, Communal category etc., through original documents. If any of their claims is found to be false or incorrect, their online application will be rejected, their provisional admission to Physical Certificate Verification-cum-Oral Test (Phase-III) will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for the said examination and whose register number is not found in the above list have not been admitted to the Physical Certificate Verification-cum-Oral Test (Phase-III) for the said recruitment.
5. The admission of candidates to Physical Certificate Verification-cum-Oral Test (Phase-III) is purely provisional subject to the decision of the Hon'ble Commission and final orders in W.A.(MD) No.181 of 2023 & CMP (MD) No.2247 of 2023 and others cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
6. The candidates who have been admitted provisionally to the Oral Test(Phase-III) are hereby advised to attend the same with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
