Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

NOTE:

1. **Mere inclusion of the register number of candidates in the above list will not imply their candidature has been fully considered for next stage of selection in the said recruitment.**
2. The candidates whose register number is found in the above list, have been provisionally admitted to the Physical Certificate Verification cum Oral Test based on the marks obtained by them in the Written Examination.
3. The admission of candidates to Physical Certificate Verification cum Oral Test is provisional subject to verification and acceptance of the claims as made in their online application with regard to Age, Educational Qualification, Community, etc., through original documents. If any of the claim of the candidates is found to be false or incorrect, their provisional admission to the Oral Test will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for the Written Examination and whose register number is not found in the above list have not been admitted to the Physical Certificate Verification cum Oral Test.

The admission of the above candidates to the Physical Certificate Verification cum Oral Test is purely provisional subject to the decision of the Commission and subject to the writ petitions relating to this recruitment pending before the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
