No individual Communication shall be sent to the candidates by Post. However, the Commission provides the additional facility to the candidates by informing the above said dates, events and intimation relating to Certificate upload, Certificate Verification and Oral Test etc., via SMS and e-mail

The admission of the candidates to Oral Test is provisional subject to verification and acceptance of the claims as made in their respective online application with regard to Age, Educational Qualification, Communal Category, Differently Abled Category, PSTM, Physical measurements etc., If any of the candidate's claims is found to be false or incorrect, their online application will be rejected and their provisional admission to Oral Test will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for the Main Written Examination and whose register numbers are not found in the above list have not been admitted to Oral Test.

The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the outcome/final orders to be passed to in W.A.(MD) No.181 of 2023 and CMP (MD) No.2247 of 2023 and W.P.No.34604 of 2022, W.P.No.24711 of 2023, W.P.No.13657 of 2024 and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
