The list of register number of 10 candidates admitted provisionally to Onscreen Certificate Verification(Phase-II) in the ratio of 1:5 for the post of Junior Scientific Officer included in Tamil Nadu Forensic Sciences Subordinate Service with respect to the 2 unfilled vacancies had been published on the Commission's website on 05.07.2024 based on the results of the examination (Computer Based Test) conducted by the Commission on 23.07.2023 FN & AN and other conditions stipulated in the said notification.

2. Based on the outcome of Onscreen Certificate Verification(Phases-I & II), the register number of candidates mentioned below have been provisionally admitted to Oral Test in the ratio of 1:3 based on the marks obtained by the candidates in the said examination and other conditions stipulated in the notification for the said recruitment. The Oral Test (Phase-II) will be held on **23.08.2024** at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai- 600 003. The candidates should attend the Oral Test(Phase-II) with all original certificates in support of the claims made in their online application. The above details will be made available in the Commission's website and the candidates will be informed of the above fact only through SMS and e-mail. Individual communication regarding the date and time of Oral Test (Phase-II) will not be sent to the candidates by post.

In the place of rejected candidates during Onscreen Certificate Verification-II, one candidate with the following register number is admitted directly to Physical Certificate Verification and Oral Test (Phase-II) and his/her admission to same is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Educational Qualification, Technical qualification, Communal category etc. Only after verification of the claims with the original certificates, his/her eligibility will become final for admission to Oral Test(Phase-II). If he/she does not produce the required certificates or if he/ she does not satisfy the eligibility criteria, his/ her online application will be rejected and his/ her provisional admission to Oral Test(Phase-II) will be cancelled and he/she will not be admitted to the next stage of selection process. Mere inclusion of the Register Number of candidate in the list does not confer any right on the part of candidate for participation in Oral test.

4. Further, one candidate who had reached the zone for Onscreen Certificate Verification (Phase-I) and not reached the zone for Oral Test(Phase-I), has now reached the zone of consideration for provisional admission to Oral Test (Phase-II), and admitted to Oral Test (Phase-II).

5. No individual communication shall be sent to the candidates by Post. However, the Commission provides the additional facility to the candidates by informing the above said dates, events and intimation relating to Certificate upload, Certificate Verification and Oral Test etc., via SMS and e-mail through their registered Mobile Number and e-mail ID. Candidates are directed to watch both the

Commission's website and X account periodically for all updates and intimations. The Commission shall not be responsible if the communication does not reach the candidate due to incorrect / invalid e-mail ID /mobile number and failure / delay in delivery of SMS / e-mail to the candidates due to any reason including technical issues. Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

**Note :-**

1. **Mere inclusion of the register number of candidates in the above list does not imply that their candidature has been fully considered for next stage of selection.**
2. The candidates whose register number is found in the above list have been admitted provisionally to the Oral Test (Phase-II) based on the marks obtained by them in the examination (Computer based Test), rule of reservation of appointment and other conditions stipulated in the notification for the said recruitment.
3. The admission of candidates to Oral Test (Phase-II) is provisional subject to verification and acceptance of the claims as made in their online application towards Age, Educational Qualification, Technical qualification and Communal category etc., through original documents. If any of their claim is found to be false or incorrect, their online application will be rejected, their provisional admission to Oral Test (Phase-II) will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for the said Computer Based Test and whose register number is not found in the above list have not been admitted to the Oral Test (Phase-II) for the said recruitment.
5. The admission of the above candidates to the Oral Test is purely provisional subject to the final orders to be passed in W.P.No.29223 of 2023, W.P.No.7697 of 2024, W.A.(MD) No.181 of

2023 and CMP (MD) No.2247 of 2023 and others cases relating to this recruitment, if any pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.

6. The candidates who have been admitted provisionally to the Oral Test (Phase-II) are hereby advised to attend the Oral Test(Phase-II) with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
7. The list of register number of candidates who were admitted to Onscreen Certificate Verification (Phase-II) but had not been considered for provisional admission to Oral Test (Phase-II) and the reason for the non-admission have been mentioned in the Annexure to this list.
