**POSTS OF ASSISTANT STATISTICAL INVESTIGATOR IN TAMIL NADU  
GENERAL SUBORDINATE SERVICE (2007 – 2011)**

The List of Register Numbers of candidates who have been provisionally selected to the Oral Test for appointment by direct recruitment to the **POSTS OF ASSISTANT STATISTICAL INVESTIGATOR in the Department of Economics and Statistics, IN THE TAMIL NADU GENERAL SUBORDINATE SERVICE (2007 – 2011)** based on the results of the Written Examination conducted by the Commission on 07-04-2013 FN & AN. was hosted in the Commission's website on 09-07-2013. They have been asked to upload and send by post as well as their certificates in support of their claim made in their online applications, for verification. Subsequently after certificate verification it is found that there are changes in the eligibility status of 122 candidates due to which provisional selection of 58 candidates stands cancelled.
