Two lists of candidates admitted provisionally to Certificate Verification for the post of **ASSISTANT ENGINEER (AGRICULTURAL ENGINEERING) INCLUDED IN TAMIL NADU AGRICULTURAL ENGINEERING SERVICE** were published in the Commission's website on 03.04.2018 and 04.06.2018 based on the results of the written examination conducted by the Commission on 07.10.2017 FN & AN.

After the 1<sup>st</sup> and 2<sup>nd</sup> Phases of Certificate Verification held on 13.04.2018 and 13.06.2018 respectively, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:2/1:3. The Oral Test will be held on **03.07.2018**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai - 600 003. The candidates will be informed through SMS and e-mail accordingly.**

5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
