SECTION - I

FUNCTIONS AND DUTIES

The Tamil Nadu Public Service Commission has to discharge the duties and functions specified in Article 320 of the Constitution of India. The Commission is required to advise Government on all matters relating to framing of recruitment rules, principles to be followed in making appointments and promotions and transfers from one service to another service, in respect of disciplinary matters affecting Government Servants and to conduct examinations for selection of candidates under direct recruitment to the State, Subordinate and Ministerial Services. The Commission conducts Departmental Examinations for Government Servants and also conducts the examination on behalf of the Government of India, Ministry of Defence, for admission to the school run by the Rashtriya Indian Military College, Dehra Dun.

10. REFORMS AND RATIONALIZATION

The Commission is continuously engaged in reviewing its selection process taking into consideration the latest developments in organisations similar to Tamil Nadu Public Service Commission engaged in recruitment work.

SECTION - II

DIRECT RECRUITMENT:

During the period, the Commission conducted Main Written Examination for 3 recruitments consisting of 55 vacancies for which 5,539 candidates were admitted. The Commission conducted oral examination for 7 recruitments containing 202 vacancies and 454 candidates were admitted to oral examination. The Commission finalised 7 recruitments containing 202 vacancies and recommended 201 candidates for appointments. The recruitment statistics in respect of 7 recruitments are given in the Annexure - II.

GROUP - I SERVICES

a. The Commission issued notification on 27.12.2000 for Group-I Services Examination containing 99 Vacancies for which 1,06,650 applications were received. The preliminary Examination was held on 10.06.2001. The Main Written Examination was held from 09.02.2002 to 13.03.2002. The Oral examination was held from 21.06.2004 to 24.06.2004. Finally 91 candidates were selected (Government reduced 8 vacancies)

MAIN WRITTEN EXAMINATION:

During the period under report, the Commission conducted 3 Main Written Examinations to fill up 55 vacancies, 5,539 candidates were admitted to these Main Written Examinations.

ORAL EXAMINATION:

During the period under report, the Commission conducted Oral Test for 7 Recruitments to fill up 202 vacancies. The Commission conducted interviews on 12 days. The Oral Tests were held in two sessions, one in the F.N. and the other in the A.N., a maximum of 5 Boards were constituted in both the sessions on some days, 454 candidates were admitted to Oral Test. Totally 74 sessions took place in 12 days for the current year.

5. CONCURRENCE UNDER RULES 20(a) (iii) OF THE SPECIAL RULES FOR THE TAMIL NADU MINISTERIAL SERVICE.

The Commission accorded its consent under the provision in Rule 20(a)(iii) of the Special Rules of Tamil Nadu Ministerial Services for the permanent transfer of 99 personnel from one departmental unit to another departmental unit within the Tamil Nadu Ministerial Service and in no case, consent was refused.

6. PROMULGATION AND AMENDMENTS:

During the period under report, there were 72 cases of issue of statutory rules or amendments to them by the Government. Of them, in respect of 71 cases, the Commission was consulted before the rules were issued and in 1 case, the Commission was not consulted. However, this case relates either to posts excluded from the purview of the Commission or to matters in respect of which under Article 320(3) of the Constitution of India, in which consultation with the Commission is not necessary.

7. RELAXATION:

During the period under report, there were 40 cases in which statutory rules relating to age and educational qualifications as the case may be, were relaxed by the Government.

SECTION - V

OTHER THAN RECRUITMENT EXAMINATIONS

1. DEPARTMENTAL EXAMINATION:

The Departmental Tests were conducted in May and December 2004. The total number of tests conducted was 257 and the number of candidates applied to the tests was 1,03,080. The details are given below:-

II. HALF YEARLY EXAMINATION:

46 and 32 candidates appeared in September 2004 and March 2005 respectively. Half Yearly Examination including First Class Language Test in Tamil was conducted for Assistant Collectors, Police Officers and Forest Officers.

III. RASHTRIYA INDIAN MILITARY COLLEGE SCHOOL, DEHRA DUN EXAMINATION:

The Commission conducted the Examination on behalf of the Government of India, Ministry of Defence in August 2004 and in February 2005 for selection of candidates for admission to Rashtriya Indian Military College School in Dehra Dun. 162 and 213 candidates respectively appeared for the examination.

SECTION - VI

Government and the Commission

A. NON ACCEPTANCE OF COMMISSION'S ADVICE:

During the year under report, the Government have deviated from the Commission's advice in 2 cases. The details are as follows:

Case 1

(G.O. 2D. No.27, Public Works (F2) Department, dated 11.06.2003)

During 1996, the Government have sought the views of the Commission as to the orders to be passed on the disciplinary action initiated against Thiru. M. Santhanam, Assistant Engineer, Public Works Department for his unauthorized absence from duty. The Delinquent Officer on the closure of RLEG Programme Sub-Division was surrendered to the Chief Engineer (General) on 30.06.1988 for issuing postings but he had not joined duty and applied leave in a piecemeal manner and extended the leave upto 15.04.1990. Then the Assistant Engineer stayed away from duty from 16.04.1990 to 09.02.1991 without any leave application and rejoined duty on 10.02.1991 F.N. Therefore disciplinary action was initiated against the Delinquent Officer and the Commission's views on the provisional conclusion arrived at by Government were sought for.

The Commission, after careful examination of the case in detail, offered its views in its letter dated 24.11.1997 as follows:-

"However, having regard to the total number of years of service put in by him and considering the fact that he has been continuously working in the Department as Assistant Engineer from 10.02.1991 (i.e.) for more than 6 years a punishment other than removal from service viz., compulsory retirement be imposed on him for the charges held proved against him. The Commission hence advises the Government to inflict the punishment of 'Compuslory Retirement' on the Delinquent Officer Thiru. M. Santhanam for the proven charges in relaxation of FR 18 (3) and to issue orders accordingly".

In 1999, the Government not agreeing with the views of the Commission, sought the revised views of the Commission. But the Commission reiterated its earlier view communicated in its letter dated 24.11.1997.

The Government have issued orders deviating from Commission's views to cut in his pension of Rs.300/- P.M. for a period of 2 years from the pension admissible to the Delinquent Officer.

Case 2

(G.O. 3(D) No.134, Home (SC) Department, dated 28.12.200

During 2003, the Government had sought the views of the Commission as to the orders to be passed on the appeal preferred by Thiru. K. Periyamuthu the then Deputy Superintendent of Police (Now retired) formerly Inspector of Police, Ooty Town West Police Station against the punishment of stoppage of increment for two years without cumulative effect awarded by the Director General of Police for the charge that "Unbecoming and reprehensible conduct in deputing two constables to accompany the dead body of one Tmt. Kamalavathy, wife of one Thiru Philip to Naduvattam on 4.2.92 without registering a case under section 174 Cr.PC. on receipt of information and when the parents of the deceased denied to accept the body, it was brought back to Ooty and then registering the case belatedly in Ooty Town West Police Station Crime No. 27/92 on 5.2.92 at 08.00 Hrs. under Section 306 IPC which subsequently ended in acquittal".

The Commission after examining the case in detail in its letter dated 22.10.2003 offered its views as follows:- "The Commission, after careful examination of the case considered that since there is no material evidence to prove that the appellant was present at the said Police Station on the date of occurrence, the punishment is recommended to be set aside and advises the Government accordingly".

The Government, have issued orders deviating from Commission's views and confirmed the punishment of withholding of increment for a period of 2 years without cumulative effect imposed on Thiru. K. Periyamuthu, formerly Inspector of Police, Ooty Town West Police Station as there is ample justification for holding the delinquencies against the Delinquent Officer as proved.

Considering the nature and circumstances of the case, the Commission advised the Government to allow his appeal setting aside the punishment of withholding of increment for a period of 2 years without cumulative effect. But the Government have issued orders deviating from Commission's advise.

B. NON-CONSULTATION WITH THE COMMISSION:

During the year under report, the Government did not consult the Commission in three cases. The details are as follows:-

Case 1.

(G.O. Ms.No.98, Home (Pol.II) Department, dated 07.02.02)

In November 2001, the Government in the Home Department informed the Commission that Thiru. S. Manoharan was appointed as Assistant Commandant in BSF on 17.09.1984 and was promoted as Deputy Commandant w.e.f. 22.09.1989. He, who was on deputation with National Security Group for sometime, was taken on deputation to Special Security Group in Tamil Nadu w.e.f. 02.08,1993 and was later absorbed permanently in the category of Additional Superintendent of Police (Category-1) w.e.f. 19.03.1996 in relaxation of rules relating to method of appointment and qualification prescribed for appointment to the post of Additional Superintendent of Police (Category-1) subject to the condition that he should undergo the training and pass the tests, prescribed for directly recruited Deputy Superintendent of Police (Category-1) successfully to keep himself equipped on par with other Additional Superintendent of Police (Category-1). On completion of the training and passing the tests he was placed above one Thiru. R. Perumal, Additional Superintendent of Police, who was selected by the Commission as SLNo.1 for appointment to the post of Deputy Superintendent of Police (Category-1) for the year 1995-1996. He was also included in the panel of Additional Superintendent of Police (Category-1) fit for appointment as temporary Superintendent of Police (Non-cadre) for the year 2000-2001 and was promoted as Superintendent of Police w.e.f. 01.10.2000. Since the name of Thiru, S., Manoharan was under consideration for inclusion in the IPS select list for the year 2001 and a deemed date for appointment in the cadre of Deputy Superintendent of Police (State Police Service) is necessary for such selection, the Government sought the views of the Commission on their proposal to consider the name of Thiru. S. Manoharan for deemed appointment in the rank of Deputy Superintendent of Police (Category-1) in the State Police Service w.e.f. 07.11.1984.

The Commission after examining the said proposal of the Government in detail, felt that it was not possible for it to accord its concurrence for the following reasons and the Government were informed accordingly:-

- i) The Officer was neither directly recruited as Deputy Superintendent of Police through Tamil Nadu Public Service Commission nor promoted by transfer from one service to another viz, from Inspector of Police to Deputy Superintendent of Police by Departmental Promotion Committee.
- ii) The Commission was not consulted while absorbing him as Additional Deputy Superintendent of Police, in relaxation of Rule 2 and 4(c) of Special Rules for the Tamil Nadu Police Service and
- iii) There is no provision at all for deemed appointment.

The Government, however, observing that the services in BSF cannot be considered to be inferior to that of State Police and therefore the services put in by the individual in BSF are equivalent to that of in Tamil Nadu State Police, in deviation of the Commission's views, issued orders for the deemed appointment of Thiru. S. Manoharan in the rank of Deputy Superintendent of Police (Category-1) in the State Police Service w.e.f. 07.11.1984.

Case 2.

- 1. G.O. (Ms) No.191, M.A & W.S (ME1.) Department dated 11.08.1999.
- 2. G.O. (Ms) No.220, M.A & W.S (ME1.) Department dated 28.09.1999.
- 3. G.O. (Ms) No. 52, M.A & W.S (ME1.) Department dated 03.05.2002.

In letters No.55848/E1/86-14, dated 18.04.1988 and No.46270A/ME.1/93-3, dated 19.02.1998, the Government, in M.A &W.S. Department forwarded draft amendments to the Special rules for the Tamil Nadu Municipal Commissioner's Service including the post of Additional Personal Assistant to the Director of Municipal Administration for the Commission's remarks. The Commission offered its views on the draft amendments in its letter No. 3495/B4/1988, dated 05.09.1988 and letter No.5560/B3/1996, dated 10.07.1998. But in G.O.(Ms)No.191, M.A & W.S(ME.1) Department dated 11.08.1999 the Government have, in supersession of the existing Special Rules for the Tamil Nadu Municipal commissioner's Service, issued revised Special Rules for the Tamil Nadu Municipal Commissioner's Service in which the post of Joint Director of Municipal Administration has been newly included straightaway without referring the draft rules for the views of the Commission and the revised Special Rules has been given effect from the date of issue of the said G.O. i.e. 11.08.1999.

In G.O.(Ms) No.220, M.A &W.S(ME.1) Department dated 28.09.1999 the dates of effect of the rules for the posts included in the said service have been changed as follows:

1. Additional P.A. to the Director of Municipal Administration — 18.02.1985

2. Municipal Commissioner, Grade-I --15.03.1993

3. Other Posts --11.08.1999

The said G.O. has been issued without consulting the Commission.

In G.O.(MS) No.52, M.A. & W.S.(ME.1)Department dated 03.05.2002 the method of appointment prescribed for the post of Municipal Commissioner, Grade-1 has been substituted by issuing an amendment and the amendment has been given effect from 03.05.2002.

The said 3 G.Os have been issued by the Government in M.A & W.S. Department without consulting the Commission. The posts included in the Tamil Nadu Municipal Commissioners Service for which revised Special Rules have been issued in G.O.(MS) No.191, M.A. & W.S. (ME.1) Department dated 11.08.1999 are included in the State Services and as such they automatically fall within the commission's purview. The Commission should have been consulted before the issue of the said G.Os. in which the revised Special rules for the Tamil Nadu Municipal Commissioner's Service (in which a new post namely Joint Director of Municipal administration had been included) and the amendments thereon have been issued. According to the instructions issued in Government U.O. Note No.4020/54-2, Public (Services) Department dated 11.09.1954 and Government letter No.63278/89-3 Personnel and Administrative Reforms (Per.M) dated 25.09.1989, the Commission should be consulted before any decision affecting the method of recruitment or the principles to be followed in making appointments to posts within its purview is taken and not merely at the time of framing of the rules or issuing amendments thereto. In Government letter No.42809/ந.ப.1/2002-1, dated 17.12.2002, the Government have stated that the amendment issued in G.O.(MS)No.52, M.A. & W.S. Department dated 03.05.2002, has been issued with the concurrence of the Law Department, so as to safeguard the service interests of the six persons who were deputed for training for Municipal Commissioner, Grade-II for a period of 2 years for appointment as Municipal Commissioner, Grade-1 as per the then existing Special Rules for the Tamil Nadu Municipal Commissioner's Service prior to the issue of the revised Special Rules issued in G.O.(MS)No.191, M.A. & W.S.(ME.1) Department dated 11.08.1999 and that the procedure to consult the Commission before the issue of the said amendment has been omitted to be followed inadvertently. The Government have requested the Commission to accord its post facto concurrence for the issue of the said amendment in G.O.(MS)No.52, M.A.& W.S.(ME1) Department dated 03.05.2002

The Government have thus not followed the principles laid down in the U.O. Note and Government letter issued by themselves.

Case 3.

(G.O.Ms.No.73 Industries department, dated 03.09.2002)

The Government in G.O. (MS) No.73 Industries Department dated 03.09.2002 without consulting the Commission issued separate adhoc rules for the post of Assistant Engineer (Drilling) in the Tamil Nadu Geology and Mining Subordinate Service in supersession of the orders issued in G.O.(MS) No.774 Industries Department dated 31.10.1989. As the adhoc rules for the said post were issued in the G.O.MS.No.774 Industries Department dated 31.10.1989 in consultation with the Commission, such consultation is necessary for the revised adhoc rules also, superseding the earlier Government Order.

The Commission should have been consulted before the issue of revised adhoc rules for the said posts. But in this case, the Commission was not consulted. According to the instructions issued in Government's Public (Services) department U.O. Note No.4020/54-2 dated 11.09.1954 and in Government Personnel and Administrative Reforms (Per.M) Department letter No.63278/89-3 dated 25.09.1989, the Commission should be consulted before arriving at a decision affecting the method of appointment or principles to be followed in making appointments and it should not be sufficient to consult at the stage of framing of rules/ issuing amendments thereto. The Government were therefore, requested to state the circumstances under which the Commission was not consulted before the issue of the said revised adhoc rules in G.O.(MS) No.73, Industries department dated 03.09.2002. In reply, the Government have stated that orders for framing of adhoc rules for the post of Assistant Engineer (Drilling) in Geology and Mining department had been issued in consultation with the Advisory Department of Secretariat / Law Department and hence the Tamil Nadu Public Service Commission has not been consulted. The Government have thus not followed their own instructions issued in Government Public (Services) U.O. Note No.4020/54-2 dated 11.09.1954 and Government, Personnel and Administrative Reforms (Per.M) Department letter No.63278/89-3 dated 25.09.1989.

C. The details of the number of cases in which the Government have not accepted the Commission's advice and the number of cases in which Government have not consulted the Commission are given for the latest five years in Annexure - XII.

MEMORANDUM EXPLAINING THE REASONS FOR DEVIATION FROM THE ADVICE OF TAMIL NADU PUBLIC SERVICE COMMISSION IN THE CASES REFERRED TO IN SECTION VI-A OF THE ANNUAL REPORT OF THE TAMIL NADU PUBLIC SERVICE COMMISSION FOR 2004-2005.

Case - 1.

(G.O. 2D No.27, Public Works (F2) Department, Dated 11.6.2003).

During 1996 the Government have sought the views of the Commission as to the orders to be passed on the disciplinary action initiated against Thiru. M.Santhanam, Assistant Engineer, Public Works Department, for his unauthorized absence from duty. The Delinquent Officer on the closure of RLEG Programme Sub-Division was surrendered to the Chief Engineer (General) on 30.6.1988 for issuing postings. But he had not joined duty and applied leave in a piecemeal manner and extended the leave upto 15.4.1990. Then the Assistant Engineer stayed away from duty from 16.4.1990 to 9.2.1991 without any leave application and rejoined duty on 10.2.1991 F.N. Therefore disciplinary action was initiated against the Delinquent Officer and the Commission's views on the provisional conclusion arrived at by Government were sought for.

The Commission, after careful examination of the case in detail, offered its views in its letter dated 24.11.1997 as follows:-

"However, having regard to the total number of years of service put in by him and considering the fact that he has been continuously working in the Department as Assistant Engineer from 10.2.1991 (i.e.) for more than 6 years, a punishment other than removal from service viz., compulsory retirement be imposed on him for the charges held proved against him. The Commission hence advises the Government to inflict the punishment of 'Compulsory Retirement' on the Delinquent Officer Thiru. M.Santhanam for the proven charges in relaxation of FR 18(3) and to issue orders accordingly".

In 1999, the Government not agreeing with the views of the Commission, sought the revised views of the Commission. But the Commission reiterated its earlier views communicated in its letter dated 24.11.1997.

The Government have issued orders deviating from Commission's views to cut in his pension of Rs.300/- P.M. for a period of 2 years from the pension admissible to the Delinquent Officer.

THE FACTORS THAT PROMPTED THE GOVERNMENT TO ISSUE AN ORDER AGAINST THE ADVICE OF THE COMMISSION ARE DETAILED BELOW:-

Thiru M.Santhanam, Assistant Engineer was on leave from 1.7.88 to 15.4.90 and was unauthorisedly absent from duty without any information from 16.4.90 to 9.2.91. He reported for duty on 10.2.91 F.N.

Disciplinary action has been initiated by framing four charges against the above Delinquent Officer for his unauthorised absence from duty under rule 17(b) of Tamil Nadu Civil Services (Discipline and Appeal) Rules. Explanation was obtained from the Delinquent Officer.. Inquiry Officer was appointed. The Inquiry Officer submitted his report holding all the four charges as proved. Based on the Inquiry Officer's report, further representation has been obtained from the individual. After examination with all the relevant records, it was provisionally concluded to "Remove him from service".

The Tamil Nadu Public Service Commission which was consulted to offer its remarks under Regulation 18(1) (a) of Tamil Nadu Public Service Commission Regulations, 1954, has advised the Government to inflict the punishment of "Compulsory Retirement" on the Delinquent Officer.

In the meanwhile, the Delinquent Officer was suspended from service and not allowed to retire on attaining the age of superannuation on 30.6.99 and his services were extended under FR 56(1) (c) till the finalisation of the disciplinary proceedings pending against him.

In the changed circumstances, the Tamil Nadu Public Service Commission was again consulted to offer its views. While offering its views, it has reiterated its earlier views of Compulsory Retirement.

In the meantime, based on the Judgement of Tamil Nadu Administrative Tribunal in similar cases necessary amendment to FR 18(3) was issued in G.O. No.153, and 154, Personnel and Administrative Reforms Department, Dated 8.8.2000, by which, action can be pursued in the cases of unauthorized absence under Rule 8 of Tamil Nadu Civil Services (Discipline and Appeal) Rules only.

Considering all the above factors, it has been decided to impose the punishment of cut in the pension of Thiru. M.Santhanam, Assistant Engineer at Rs.300/- per month for a period of two years. A show cause notice was sent to Thiru M.Santhanam, Assistant Engineer, Public Works Department to offer his views on the proposed quantum of punishment. The Delinquent Officer has given his consent to the above proposed punishment. Accordingly, orders were issued in G.O.(2D)No.27, Public Works Department, Dated 11.6.2003 imposing the punishment of cut-in-pension at the rate of Rs.300/- per month from the pension of Thiru M.Santhanam, Assistant Engineer, Public Works Department, for a period of two years for the proven charges.

Case 2.

(G.O. 3(D) No.134, Home (SC) Department, Dated 28.12.2004)

During 2003 the Government had sought the views of the Commission as to the orders to be passed on the appeal preferred by Thiru K.Periyamuthu the then Deputy Superintendent of Police (Now retired) formerly Inspector of Police, Ooty Town West Police Station against the punishment of stoppage of increment for two years without cumulative effect awarded by the Director General of Police for the

charge that "Unbecoming and reprehensible conduct in deputing two constables to accompany the dead body of one Tmt. Kamalavathy, wife on one Thiru Philip to Naduvattam on 4.2.92 without registering a case under section 174 Criminal Penal Code on receipt of information and when the parents of the deceased denied to accept the body, it was brought back to Ooty and then registering the case belatedly in Ooty Town West Police Station Crime No.27/92 on 5.2.92 at 08.00 Hrs. under Section 306 Indian Penal Code which subsequently ended in acquittal".

The Commission after examining the case in detail in its letter dated 22.10.2003 offered its views as follows:-

"The Commission, after careful examination of the case considered that since there is no material evidence to prove that the appellant was present at the said Police Station on the date of occurrence, the punishment is recommended to be set aside and advises the Government accordingly".

The Government, have issued orders deviating from Commission's views and confirmed the punishment of withholding of increment for a period of 2 years without cumulative effect imposed on Thiru K.Periyamuthu, formerly Inspector of Police, Ooty Town West Police Station as there is ample justification for holding the delinquencies against the Delinquent Officer as proved.

Considering the nature and circumstances of the case, the Commission advised the Government to allow his appeal setting aside the punishment of withholding of increment for a period of 2 years without cumulative effect. But the Government have issued orders deviating from Commission's advice.

THE FACTORS THAT PROMPTED THE GOVERNMENT TO ISSUE AN ORDER AGAINST THE ADVICE OF THE COMMISSION ARE DETAILED BELOW:-

Thiru K.Periyamuthu, formerly Inspector of Police, Udhagai Town West Police Station was dealt with under rule 17(a) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules, for certain lapses committed by him and the Director General of Police imposed the punishment of 'withholding of increment for a period of two years without cumulative effect' on him for the proved charge.

Thiru K.Periyamuthu preferred an Appeal to Government and the Tamil Nadu Public Service Commission was consulted in the matter. The Tamil Nadu Public Service Commission in its letter dated 22.10.2003, among other things, has stated that the appellant does not seem to have been given reasonable opportunity to defend himself against the charge, that considering the gravity of lapse, the case should have been processed under Rule 17(b) instead of 17(a), that this would have created all the avenues and opportunities for the appellant to defend himself and conduct of an oral enquiry would have gone to prove as to who was the actual culprit and concluded that since there is no material evidence to prove that the appellant was present at the said Police Station on the date of occurrence, the punishment is to be set aside.

The Government examined the views of the Tamil Nadu Public Service Commission with reference to the explanation of the Delinquent Officer and with reference to the theory 'Preponderance of Probability'. The Director General of Police after considering the representation of Thiru Periyamuthu, has relied upon the deposition made by Thiru Philip (husband of the deceased Kamalavathy) mentioned in the Judgement, that the complaint was orally made by Thiru Philip at the Police Station and Thiru Periyamuthu, Inspector of Police, who was present at that time in the Police Station refused to register a case and sent back the dead body with the Police Constables, that the case was not registered even on 4.2.92 night and when the dead body was returned to Police Station, but only on 5.2.92 (para 4 & 15 of the Judgement). The Director General of Police has arrived at a conclusion that there is no reason for Thiru Philip to depose falsely before the Court and imposed the punishment of his 'next increment be withheld for a period of two years without cumulative effect. Further, for a 17(a) charge oral enquiry is not The punishment awarded by the Director General of Police on the Delinquent Officer does not affect his pension and the period of punishment does not exceed three years as per the proviso of Rule 17(a) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules. Only if the punishment exceeds three years or if the increment is withheld with cumulative effect then the 17(b) procedure has to be adopted.

Under the above circumstances, the views of the Tamil Nadu Public Service Commission was deviated and the appeal of Thiru K.Periyamuthu was rejected and the punishment awarded on him was confirmed in G.O.3(D)No.134, Home(SC)Department, Dated 28.12.2004.
