## **SECTION - I**

### **FUNCTIONS AND DUTIES**

The Tamil Nadu Public Service Commission has to discharge the duties and functions specified in Article 320 of the Constitution of India. The Commission is required to advise the Government on all matters relating to framing of recruitment rules, principles to be followed in making appointments and promotions and transfers from one service to another service, in respect of disciplinary matters affecting Government Servants and to conduct examinations for selection of candidates under direct recruitment to the State, Subordinate and Ministerial Services. The Commission conducts Departmental Examinations for Government Servants and also conducts the examination on behalf of the Government of India, Ministry of Defence, for admission to the school run by the Rashtriya Indian Military College, Dehra Dun.

**10. REFORMS AND RATIONALIZATION**

The Commission is continuously engaged in reviewing its selection process taking into consideration the latest developments in organisations similar to Tamil Nadu Public Service Commission engaged in recruitment work.

## **SECTION - II**

### **DIRECT RECRUITMENT:**

During the period under report the Commission finalised 6 recruitments containing 2599 vacancies and recommended 2305 candidates for appointments. The recruitment statistics in respect of 6 recruitments are given in the Annexure - II.

### **MAIN WRITTEN EXAMINATION:**

During the period under report, the Commission conducted 4 Main Written Examinations to fill up 1583 vacancies. 1,95,644 candidates were admitted to these Main Written Examinations.

### **ORAL EXAMINATION:**

During the period under report, the Commission conducted Oral Test for 4 Recruitments to fill up 301 vacancies. The Commission conducted interviews on 9 days. The Oral Tests were held in two sessions, one in the F.N. and the other in the A.N., a maximum of 6 Boards were constituted in both the sessions on some days, 618 candidates were admitted to Oral Test. Totally 46 sessions took place in 9 days for the current year.

The details of Preliminary, Main Written Examination and Oral Examinations conducted are given in Annexure-V.

## **SECTION - III**

**Paucity of Qualified and Suitable candidates:-** There were paucity of qualified and suitable candidates for the post of Assistant Surgeon Speciality. As a result 293 vacancies in the speciality subjects could not be filled up during this year. The details are given in Annexure -VI.

### **RECRUITMENT BY TRANSFER / PROMOTION , DISCIPLINARY CASES, APPEALS, PETITIONS, STATUTORY RULES, REGULATION, TEMPORARY APPOINTMENTS ETC.,**

#### **1. RECRUITMENT BY TRANSFER / PROMOTION:**

During the period, the Commission dealt with references relating to recruitment by transfer to State Services from the corresponding Subordinate Services and by promotions within the State Services and drew up lists of 843 qualified and suitable candidates for appointment to the posts under 20 Services. Details are furnished in Annexure-VII.

**5. CONCURRENCE UNDER RULES 20(a) (iii) OF THE SPECIAL RULES FOR THE TAMIL NADU MINISTERIAL SERVICE.**

The Commission accorded its consent under the provision in Rule 20(a)(iii) of the Special Rules of Tamil Nadu Ministerial Services for the permanent transfer of 52 personnel from one departmental unit to another departmental unit within the Tamil Nadu Ministerial Service and in no case, consent was refused.

**6. PROMULGATION AND AMENDMENTS:**

During the period under report, there were 31 cases of issue of statutory rules or amendments to them by the Government. Of them, in respect of all cases, the Commission was consulted before the rules were issued.

**7. RELAXATION:**

During the period under report, there is no case in which statutory rules relating to age and educational qualifications as the case may be, were relaxed by the Government.

## **SECTION – V**

### **OTHER THAN RECRUITMENT EXAMINATIONS**

#### **I. DEPARTMENTAL EXAMINATION:**

Departmental Tests were conducted in May and December 2006. The total number of tests were conducted 305 and the number of candidates applied to the tests were 86,991.

#### **II. HALF YEARLY EXAMINATION:**

42 and 35 candidates appeared in September 2006 and March 2007 respectively. Half Yearly Examination including First Class Language Test in Tamil was conducted for Officers of Indian Administrative Service, Indian Police Service, Indian Forest Service and State services.

#### **III. RASHTRIYA INDIAN MILITARY COLLEGE SCHOOL, DEHRA DUN EXAMINATION:**

The Commission conducted the Examination on behalf of the Government of India, Ministry of Defence in August 2006 and in February 2007 for selection of candidates for admission to Rashtriya Indian Military College School in Dehra Dun. 120 and 110 candidates respectively appeared for the examination.

## **SECTION – VI**

### **Government and the Commission**

#### **A. NON ACCEPTANCE OF COMMISSION'S ADVICE:**

During the year under report, the Government have deviated from the Commission's advice in four cases. The details are as follows:

##### **CASE -I**

(G.O.(3D) No.29,Animal Husbandry, Dairying and Fisheries (F.S.III) Department, dated 22.9.06)

During November 1998, the Government forwarded the records relating to the disciplinary action initiated against Thiru.J.Janardhanan, Selection Grade Inspector of Fisheries, and sought the views of the Commission under Regulation 18 (1) (b) of Tamil Nadu Public Service Commission Regulations, 1954, as to the orders to be passed on the case. The commission, after careful examination, advised the Government to remove the delinquent officer from service vide its letter dated 22.10.1999.

Again, during December 2000, the Government sought the revised views of the Commission, under Regulation 18 (1) (b) (iii) of Tamil Nadu Public Service Commission Regulations, 1954, stating that they have proposed to impose a punishment other than removal from service, by relaxing the provision under Fundamental Rules 18 (3) in favour of the delinquent officer, as a special case, considering the fact, that the delinquent officer was mentally not sound, that his wife and children were wholly dependent on him and that if a capital punishment was ordered, it would certainly land him in the streets and his family thrown into hardship and poverty and that accordingly, orders were obtained upto Her Excellency the Governor of Tamil Nadu to relax Fundamental Rules 18 (3) in favour of the delinquent officer and to seek the views of the Tamil Nadu Public Service Commission under regulation 18 (1) (b) (iii) only, but the Tamil Nadu Public Service Commission was addressed for its views under Regulation 18 (1) (b).

The Commission., during January 2001, called for the connected records to offer its views on the case. The Government, till August 2006, had not sent the required records.

Later, in view of the unsound mental condition of the delinquent officer, the Government decided to treat the period of suspension of Thiru.J.Janardhanan, Selection Grade Inspector of Fisheries, from 26.10.99 to 31.10.99, as substantive punishment and to deem that he was retired from service attaining the age of superannuation, on 31.10.1999 A.N. so as to enable him to get usual retirement benefits and issued orders accordingly in G.O. (3D) No.29, Animal Husbandry, Dairying and Fisheries (FS.III) department, dated 22.9.2006 deviating from the views of the Commission.

Considering the nature and circumstances of the case, the Commission advised the Government to remove the delinquent officer from service. But the Government issued orders deviating from Commission's advice.

**CASE-II**

[G.O.(3D)NO. 9, Animal Husbandry, Dairy Development and Fisheries (AH.1) Department, dated 7.3.2006]

Disciplinary action was initiated against Thiru. P.Paulraj (Review petitioner), formerly Veterinary Assistant Surgeon, Veterinary Dispensary, Parakkai by framing charges under Rule 17 (b) of the Tamil Nadu Civil Services (Discipline & Appeal ) Rules and his explanation was obtained. The Government holding certain charges as proved, came to a provisional conclusion for awarding punishment for the proved charges and sought the Commission's views. The Commission examined the case in detail and advised the Government to award the punishment of removal from service to the Review Petitioner for the charges held proved against him. The Government accepted the above views of the Commission and issued orders imposing the punishment of "Removal from service" on the Review Petitioner.

Aggrieved by the above punishment, the Review Petitioner preferred a Review Petition to the Government. The Government forwarded the above Review Petition with the connected records and sought the views of the Commission on the Review Petition. The Commission, after examining the case, found that no fresh and acceptable points had been put forth in the Review Petition and that the Inquiry Officer had held the charges as proved with clear evidence. Therefore the Commission advised the Government to reject the Review Petition, which had no substance and acceptable explanations.

However, the Government have issued orders deviating from the above views of the Commission and modified the punishment of "Removal from service" already imposed on the Review Petitioner into one of 'stoppage of increment for four years with cumulative effect'. Considering the gravity of the delinquencies committed by the Review Petitioner, the Commission advised the Government to reject his Review Petition. But the Government have issued orders deviating from the Commission's advice.



**CASE-III****G.O.(D) No.1206,Home (Prison 2) Dept. dated 18.12.2006.**

Disciplinary action was taken against Thiru.K.Salamon, formerly Constable, Grade – II, Central Prison, Trichy, under rule 17(b) of Tamil Nadu civil Services (Discipline and Appeal) Rules for his certain immoral activities while he was sent for Training from Trichy Central Prison to Vellore Police Training School. As the immoral activities of the Petitioner was considered that it would encourage other trainees also, the punishment of dismissal from service was imposed on him by the Superintendent, Central Prison. The appeal against the punishment to the DIG of Prison, Chennai Region and Petition to the Additional DGP of Prisons, were rejected.

Thiru.K.Salamon, has submitted a petition to the Government against the punishment imposed. The Government sought the views of the Commission in January 2006 as to the orders to be passed on the petition.

The Commission, in its views, stated that the punishment of dismissal from service imposed on the petitioner was proportionate to the gravity of charges and advised the Government to reject the petition as devoid of merits.

But, the Government issued orders in G.O.(D)No.1206, Home (Prison2) Dept, dated 18.12.2006., deviating from the views of the Commission stating that the punishment of dismissal from service imposed on the petitioner was very severe one and that they decided to allow the petitioner to rejoin in government service by canceling the punishment order already issued and then to impose the punishment of stoppage of increment for five years with cumulative effect on the Petitioner, affecting his pension. (inclusive of leave, if any, (excluding C.L.) spent by the Review Petitioner, before the punishment is completed.)

The Commission advised the Government to reject the petition whereas the Government issued orders deviating from its advice.

**CASE-IV****G.O.(D) No.640, Rural development and Panchyat Raj (E2) Dept. dated 01.11.2006.**

In the case relating to the disciplinary action against Thiru.S.B.Kamalakannan (Retd) formerly extension Officer (Panchayat), Hosur Panchayat Union, Krishnagiri district, on charges of certain irregularities in the purchase of pipes and specials etc., for the maintenance of power pumps of water supply Schemes in Hosur Panchayat Union, the government arrived at a provisional conclusion to impose a punishment of cut in pension of Rs. 50/- per month for a period of 6 months and sought the views of the Commission in September 2005.

The Commission sent its views to the effect that " since disciplinary proceedings on the co-delinquent Thiru.M.Nanjundan for the same delinquency were dropped by Government on the direction of Tamil Nadu Administrative Tribunal, the Commission feels that the Delinquent Officer also may be treated in the same way and advises the Government to drop the proceedings against Thiru.S.B.Kamalakannan".

But, the Government issued orders in G.O.(D) No.640, Rural development and Panchyat Raj (E2) Dept, dated 01.11.2006, deviating from the Commission's views and imposed the punishment of cut in pension of Rs. 50/- per month for a period of six months on the Delinquent Officer for the proven charges.

The Commission advised the Government to drop the disciplinary proceedings against Thiru.S.B.Kamalakannan. But the Government issued orders deviating from the Commission's advice.

**B. Non-consultation with the Commission : Nil**

C. The Government have violated their own instructions and the Commission trust that this will not recur in future. Details of the number of cases in which Government have not accepted the Commission's advice and the number of cases in which Government have not consulted the Commission are given for the last five years in Annexure – XII.

## **ACKNOWLEDGEMENT**

The Commission records its appreciation for the co-operation extended by various educational Institutions and their officers in the matter of providing suitable accommodation for the various examinations held by the Commission.

The Commission is also grateful to the examiners and experts who, inspite of their personal inconvenience, readily accepted the Commission's invitation and assisted them in the conduct of different examinations and selection of officers to various posts under the State Government.

The Commission expresses its sincere thanks to all the Secretaries to Government and Heads of Departments for their kind co-operation in finalising the selection of candidates for appointment by recruitment by transfer/promotion through the Departmental Promotion Committees.

In conclusion, the Commission also places on record its appreciation of the Co-operation and efforts of the personnel in the smooth functioning of the Commission.

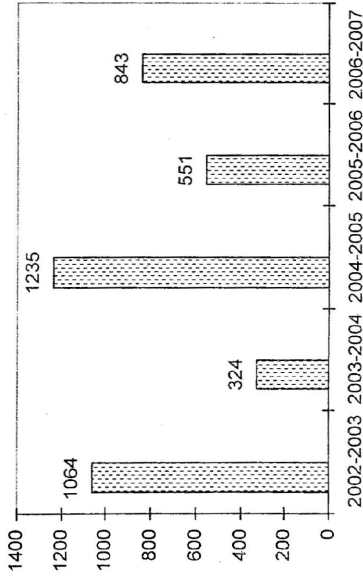

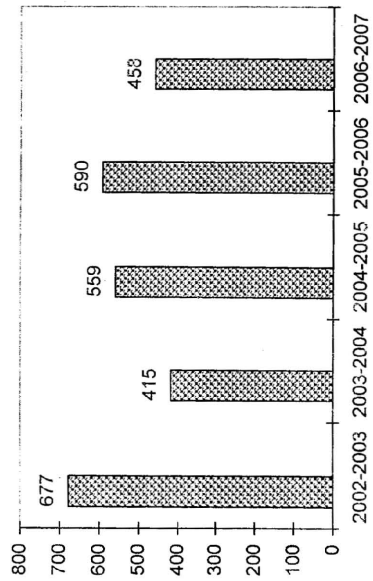
