SECTION - I

FUNCTIONS AND DUTIES

The Tamil Nadu Public Service Commission has to discharge the duties and functions specified in Article 320 of the Constitution of India. The Commission is required to advise the Government on all matters relating to framing of recruitment rules, principles to be followed in making appointments and promotions and transfers from one service to another service, in respect of disciplinary matters affecting Government Servants and to conduct examinations for selection of candidates under direct recruitment to the State, Subordinate and Ministerial Services. The Commission conducts Departmental Examinations for Government Servants and also conducts the examination on behalf of the Government of India, Ministry of Defence, for admission to the school run by the Rashtriya Indian Military College, Dehra Dun.

REFORMS AND RATIONALIZATION**

The Commission is continuously engaged in reviewing its selection process taking into consideration the latest developments in organizations similar to Tamil Nadu Public Service Commission engaged in recruitment work.

Group-I Services Scheme of Examinations modification:

As per the recommendations of the Sub-Committee, the Commission has decided to implement the new scheme of Examination for Group-I Services Main Written Examination. It consists of Two papers in descriptive type in General Studies, each paper 3 hours duration and 300 marks. The notification for Group-I Services Examination in the new scheme was issued on 01.08.2007. New pattern helps to cut down the time taken in conducting Examinations, reduce cost, provide results in the shortest possible time and to eliminate the variation in performance among subjects and Examiners.

SECTION - II

DIRECT RECRUITMENT:

During the period under report the Commission finalised 20 recruitments containing 4328 vacancies and recommended 4303 candidates for appointments. The recruitment statistics in respect of 20 recruitments are given in the Annexure - II.

PRELIMINARY EXAMINATIONS :

During the period under report, the Commission conducted one Preliminary Examinations for Group-I Services to fill up 172 vacancies, 1,09,851 candidates were admitted to this Preliminary Examination.

MAIN WRITTEN EXAMINATION:

During the period under report, the Commission conducted 25 Main Written Examinations to fill up 13,485 vacancies. 11,01,915 candidates were admitted to these Main Written Examinations.

ORAL EXAMINATION:

During the period under report, the Commission conducted Oral Test for 18 Recruitments to fill up 2251 vacancies. The Commission conducted interviews on 54 days. The Oral Tests were held in two sessions, one in the F.N. and the other in the A.N., a maximum of 7 Boards were constituted in both the sessions on some days, 3705 candidates were admitted to Oral Test. Totally 510 sessions took place in 54 days for the current year.

The details of Preliminary, Main Written Examination and Oral Examinations conducted are given in Annexure-V.

SECTION - III

Paucity of Qualified and Suitable candidates:- There were paucity of qualified and suitable candidates for the post of Assistant Medical Officer (Unani)-11, C.S.S.E-I - 5, Accounts Officer Class-III - 8. As a result 24 vacancies could not be filled up during this year. The community wise details are given in Annexure -VI.

In none of the cases concurrence was accorded for continuance of temporary appointment for more than 24 months.

5. CONCURRENCE UNDER RULES 20(a) (iii) OF THE SPECIAL RULES FOR THE TAMIL NADU MINISTERIAL SERVICE.

The Commission accorded its consent under the provision in Rule 20(a)(iii) of the Special Rules of Tamil Nadu Ministerial Services for the permanent transfer of 63 personnel from one departmental unit to another departmental unit within the Tamil Nadu Ministerial Service and in no case, consent was refused.

6. PROMULGATION AND AMENDMENTS:

During the period under report, there were 49 cases of issue of statutory rules or amendments to them by the Government. Of them, in respect of 42 cases, the Commission was consulted before the rules were issued and in 7 cases the Commission was not consulted. However, these cases relate either to posts excluded from the purview of the Commission or to matters in respect of which under Article 320(3) of the Constitution of India, consultation with Commission is not necessary.

7. RELAXATION:

During the period under report, there were 47 cases in which statutory rules relating to age and educational qualifications as the case may be, were relaxed by the Government.

OTHER THAN RECRUITMENT EXAMINATIONS

I. DEPARTMENTAL EXAMINATION:

Departmental Tests were conducted in May and December 2007. The total number of tests were conducted 283 and the number of candidates applied to the tests were 87,910

II. HALF YEARLY EXAMINATION:

13 and 7 candidates appeared in September 2007 and March 2008 respectively. Half Yearly Examination including First Class Language Test in Tamil was conducted for Officers of Indian Administrative Service, Indian Police Service, Indian Forest Service and State services.

III. RASHTRIYA INDIAN MILITARY COLLEGE SCHOOL, DEHRA DUN EXAMINATION:

The Commission conducted the Examination on behalf of the Government of India, Ministry of Defence in August 2007 and in February 2008 for selection of candidates for admission to Rashtriya Indian Military College School in Dehra Dun. 111 and 110 candidates respectively appeared for the examination.

SECTION – VI

Government and the Commission

A. NON ACCEPTANCE OF COMMISSION'S ADVICE:

During the year under report, the Government have deviated from the Commission's advice in six cases. The details are as follows:

Case-I

(G.O. (2D) No.66, Rural Development (g/m) Department, dated 18.10.2007

In December 2006, the Government sought the views of the Commission on the appeal preferred by Thiru.J.M.Manohar, Extension Officer (Accounts) against the punishment of "Censure".

The Commission after examining the case in detail agreed to the findings of the Director of Rural Development. Further the Commission was of the opinion that the punishment of "Censure" imposed on the appellant was not on the higher side to be interfered with and hence advised the Government to reject the appeal as devoid of merits as the appellant had not put forth any new grounds in it.

But, the Government have considered the following points put forth by the appellant in his appeal that he had been transferred twice within a span of one year, that when he was transferred from D2 seat to "Indra Memorial Housing" Section he had submitted a petition to the Director of Rural Development to reconsider his transfer and that he had continued to work in the D2 seat under the impression that his petition was under consideration of the Director of Rural Development, that nobody else was posted to D2 seat and his higher officers too had not advised him to go on transfer from D2 seat, that if the intention of the appellant was to ignore the orders of the Director of Rural Development he would have proceeded on leave, instead he had continued his work thereby enabled the office to function without any slackness, that he had continued in the seat in order to hand over the Original records of the Section to the person to be posted to that seat and that he was also about to undergo training for 9 months shortly. The Government therefore decided to deviate from the advice of the Commission to reject the appeal and issued orders setting aside the punishment of "Censure" imposed on the appellant.

Considering the nature and circumstances of the case, the Commission advised the Government to reject the appeal. But the Government have issued orders, deviating from the advice of the Commission.

Case-II

(G.O.(Ms).No.2, Small Industries (E-II-2) Department, dated 19.01.2007)

In the case relating to the disciplinary action against Thiru.P.Periyanayagam, Chief Instructor, Technical Training Centre, Guindy formerly working as Assistant Engineer, District Industries Centre, Virudhunagar and Thoothukudi, on charges of certain allegations, the Government arrived at a provisional conclusion to impose the punishment of "Dismissal from service" for the proven charges and sought the views of the Commission in their letter dated 25.07.2005.

The Commission tendered its views in its letter dated 04.04.2006, agreeing with the Government's proposal to impose the punishment of "Dismissal from service" on the delinquent officer and advised accordingly.

But, the Government issued orders in G.O. (Ms) No.2, Small Industries (E.II.2) Department, dated 19.01.2007 deviating from the Commission's views and imposed the punishment of Compulsory retirement from Government Service on the delinquent officer for the proven charges.

The Commission advised the Government to impose the punishment of "Dismissal from service" on the delinquent officer. But the Government issued orders deviating from the Commission's advice.

Case-III**G.O.(D).No.26, T.D.E. and Information (End.2) Department, dated 25.1.2007.**

During 2005, the Government had sought the views of the Commission as to the orders to be passed on the appeal preferred by Thiru.A.T. Paranjothi, Assistant Commissioner/Executive Officer, Arulmigu Swaminathasami Tirukoil, Swamimalai against the punishment of "Censure" imposed on him for the proven charges that he failed to submit a report on the action taken by the administration, based on a complaint thereby disobeying the orders of Superiors. The Commission, after examining the case in detail, found that the appellant did not send any reply as requested in the letter dated 9.10.2002 till such time charges were framed, that moreover, he did not send any reply to the four reminders and in his appeal, he had stated that he could not submit the report in time as the Manager and Revenue Section Writer concerned were on unauthorized absence for more than one year, which could not be accepted. To avoid further delay, the appellant could have sent an interim reply. But this was also not done. The Commission, therefore, advised the Government to reject the appeal in its letter dated 23.1.2006. But the Government issued orders deviating from the Commission's views, allowing the appeal preferred by the appellant and setting aside the punishment order issued by the Commissioner of Hindu Religious and Charitable Endowments Department, Chennai.

Case-IV**G.O.(Rt).No.1207, Home (Prison-2) Department, dated 18.12.2006.**

Disciplinary action was initiated against one Thiru.M.Jeyakumar (petitioner) by framing a charge under Rule 17(b) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules for his indisciplined act towards his superior while undergoing training at Police Training School, Vellore on his appointment as Police Constable, Grade-II, Central Jail, Trichy and his explanation obtained. It was concluded finally that the charge against the petitioner was proved and for the proven charge the punishment of "Dismissal from service" was imposed on the petitioner by the order of the Superintendent, Central Jail, Vellore.

Aggrieved by the above punishment, the petitioner preferred an appeal to the Inspector General of Prisons, Chennai circle and thereafter, a revision petition to the Additional Director of Prisons, Chennai, which were all rejected. Finally, the petitioner preferred a petition to the Government. The Government, in the year 2005, forwarded the above petition with connected records and sought the Commission's views on the petition. The Commission, after examining the case with the relevant records, viewed that the act of the petitioner amounted to indiscipline perpetrated in the presence of the Trainee – Constables, that it was a misdeed deranging the tenet of tolerance expected of the uniformed service and that it would instigate the fellow – trainees to resort to such thing. The Commission, so viewing, advised the Government to issue orders confirming the punishment of "Dismissal from service" imposed on the petitioner.

However, the Government, in deviation from the above views of the Commission, issued orders reinstating the petitioner into service by setting aside the punishment of "Dismissal from service" already imposed on him and imposing on him the punishment of "stoppage of increment for five years with cumulative effect" instead of "Dismissal from service".

Considering the gravity of the delinquently committed by the petitioner, the Commission advised the Government to issue orders confirming the punishment of "Dismissal from Service" imposed on the petitioner. But the Government issued orders deviating from the Commission's advice.

Case-V**G.O.(D).No.161, Co-operation, Food and Consumer Protection Department,
dated 28.5.2007.**

In November 2005, the Government had sought the views of the Commission on the disciplinary action taken against Thiru.V.Bagavathi Pandi, Sub-Registrar of Co-operative Societies (retired), under rule 17(b) of Tamil Nadu Civil Services (Discipline and Appeal) Rules and Tamil Nadu Pension Rule for the irregularities committed by him in the appointment of 5 persons under 18(1) contract and appointment of 4 persons on daily wages basis while serving in Kamudhi as Sub-Registrar of Co-operative Societies / Management Director during 14.12.1997 to 25.05.2000 and on their provisional conclusion to inflict the punishment of cut in pension of Rs.200/- per month for 6 months on the delinquent officer.

The Commission after examining the case in detail, agreed to the provisional conclusion arrived at by the Government to inflict the punishment of cut in pension of Rs.200/- per month for 6 months.

The Government, deciding not to press the charges against the delinquent officer and to drop further action on him in order to implement the judgements pronounced by Tamil Nadu Administrative Tribunal and High Court, Madras, had in February 2007, again referred the case to the Commission and sought its revised views.

The Commission again examined the case in detail and decided that the Government had not put forth any points for their decision not to press the charges against the delinquent officer and decided that there was no valid grounds to revise the views and therefore, reiterated its earlier views to the Government.

But the Government deviating from the Commission's views, have issued orders dropping the charges framed against the delinquent officer on the ground the delinquent officer had moved the court for contempt.

Considering the nature and circumstances of the case, the Commission advised the Government to inflict the punishment as proposed by the Government. But the Government have issued orders deviating from the advice of the Commission.

Case –VI**G.O.(D).No.93, Rural Development and Panchayat (E1), dated 02.03.2007.**

Disciplinary action was initiated against one Thiru.S.Balasubramanian (appellant) by issuing showcause notice under Rule 17(a) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules for his failure to inspect personally the Health Complexes, for his having allowed water connection to the Health Complexes from the drinking water pipe line instead of arranging separate water supply resources for the Health Complexes, for his failure to complete the construction of the Health Complexes for his failure to supervise the construction works of the Health Complexes from time to time etc. while working as Project Officer, Thiruvallur District and his explanation obtained. The Director of Rural Development, who examined the case with relevant records, considered that the lapses pointed out in the charge memo are proved and for the proven lapses he imposed the punishment of "Stoppage of increment for one month without cumulative effect" on the appellant.

Aggrieved by the above punishment, the appellant preferred an appeal to the Government. The Government, in 2004, forwarded the above appeal with connected records and sought the Commission's views on the appeal. The Commission, after examining the case with the relevant records, found that the appellant had performed his works in an irresponsible manner and that he had shirked his duties. The Commission, therefore, advised the Government to issue orders dismissing the appeal of the appellant.

However, the Government, in deviation from the above advice of the Commission, issued orders canceling the order of the Director of Rural Development imposing punishment on the appellant and exonerating him from the charges.

Finding that the appellant had actually committed the lapses in the case, the Commission advised the Government to issue orders for confirming the punishment of "Stoppage of increment for one month without cumulative" imposed on him. But the Government have issued orders deviating from the Commission's advice.

B. Non-consultation with the Commission :

During the year under report, the Government did not consult the Commission in one case. The details are as follows:-

Case-I

The post of Assistant Executive Engineer (Electrical) in Public Works Department in the Tamil Nadu Engineering Service is within the purview of the Commission. Therefore, appointment to the post has to be made in consultation with the Commission. Therefore, based on the proposals received from the Government, the selection for appointment to the post of Assistant Executive Engineer (Electrical) in Public Works Department in the Tamil Nadu Engineering Service for the year 2004-2005 was finalized by the Departmental Promotion Committee in its meeting held on 22.05.2006 against 14 vacancies. Out of the 14 vacancies 10 vacancies have to be filled up by promotion from the Assistant Engineer, Public Works Department and 4 vacancies have to be filled up from the Junior Engineers of Public Works Department by recruitment by transfer. Therefore 10 Assistant Engineers and 4 Junior Engineers were recommended for appointment against the vacancies by the Departmental Promotion Committee, comprising of an Hon'ble Member of the Commission as its Chairman, Secretary, Public Works Department as the convenor and member of the Departmental Promotion Committee, Chief Engineer, Public Works Department, and the Deputy Secretary, Personnel and Administrative Reforms Department representing the Secretary to Government, Personnel and Administrative Reforms Department as its other Members. Selvi Doris Margaret Varadarajulu and V. Balasubramanian were the two among the 10 Assistant Engineers who were recommended by the Departmental Promotion Committee for appointment as Assistant Executive Engineers.

However, the Government, in G.O.Ms.No.459, Public Works Department, dated 27.10.2006 while approving the list, did not approve the names of Selvi Doris Margaret Varadarajulu and

V. Balasubramanian. The Government in this connection have stated that the merits of the above two individuals were found to be comparatively less and hence their names have not been included in the panel. Since the said reason is not specific, the Government were requested to state the specific reasons due to which their merits were considered as comparatively less.

In this connection, the Government have stated as follows:-

“Among others, the names of 10 Assistant Engineers have been considered for the post of Assistant Executive Engineer (Electrical) for the year 2004-2005. It has been verified from the resume of personal file of the Assistant Engineers for the last 5 years that the rating of 8 officers have been found to be Good or Very Good or Outstanding. But the rating of other two officers namely Selvi. Doris Margaret Varadarajulu and Thiru.V.Balasubramanian, Assistant Engineers have been found to be average for some period for the past 5 years. The perusal of Personal Files, reveal that the merits of above two officers are comparatively less, than the other 8 officers. It is considered that it is bounden duty of Government to decide for promotion of the officers to any higher post taking into consideration of all aspects. So even after the Departmental Promotion Committee's recommendation, the merits of Selvi. Doris Margaret Varadarajulu and Thiru.V.Balasubramanian, Assistant Engineers have been taken into account by the Government before issuing final orders and their names have not been considered as their merits were found to be comparatively less, than other officers fit for promotion for the post of Assistant Executive Engineer, accordingly orders have been issued in G.O.Ms.No.459, Public Works Department, dated 27.10.2006 for the post of Assistant Executive Engineer deleting the names of the above two officers after following the procedures prescribed in instruction 95 of the Secretariat Business Rules. In respect of Selvi.Doris Margaret Varadarajulu and Thiru.V.Balasubramanian, Assistant Engineers, their names have not been included in the panel for the post of Assistant Executive Engineer (Electrical) for the year 2004-2005 as their merit is comparatively less than others. Other candidates eligible as per rules have been included”.

The 5 years check period for the 2004-2005 panel is from 1.4.1999 – 31.3.2004. In the individual proforma of the individuals in respect of Selvi. Doris Margaret Varadarajulu "Average" rating has been recorded for the period from 1.4.2003 – 31.3.2004. In respect of Thiru.V.Balasubramanian he has been rated as Average for the period from 1.4.1999 – 31.3.2000, 11.12.2000 – 31.3.2001, 3.1.2003 – 31.3.2003. Normally, the Average rating is not being held against the individuals. Only the specific adverse remarks such as satisfactory with shortcoming etc. are being held against the officials. Even in those cases also, such adverse remarks should have been communicated to the individuals and their acknowledgement therefor should have been obtained from them. In their cases the "average" rating do not seem to have been communicated to them and it may be due to the reasons that the average rating is not the one which disqualify the promotion. The Secretary to Government, Public Works Department, the Chief Engineer (General) Public Works Department, (Head of the Department), and the representative of the Personnel and Administrative Reforms Department, who participated in the Departmental Promotion Committee meeting as the Members of the Departmental Promotion Committee did not also take any objection while recommending the names of the above two individuals for the panel for the year 2004-2005 and the very fact goes to prove that the average rating is not a bar for promotion. Even, in the very same meeting in which the selection for appointment to the post of Assistant Executive Engineer (Civil) for the year 2004 – 2005 was also finalized, with the very same dignitaries, some of the individuals to whom also "average" ratings have been recorded were also recommended for inclusion in the panel and their names have also been approved by the Government in G.O.Ms.No.3(D) No.28, Public Works Department dated 22.06.2006 for inclusion in the panel.

Even if the Government desire not to approve their names for one or other reasons, in as much as their names having been recommended by the Departmental Promotion Committee for inclusion in the panel, the proper course left to the Government is to consult the Commission beforehand, duly assigning the reasons therefor and to get its concurrence for such non-approval. In the circumstances, the reasons now putforth by the Government for non-inclusion of the names of the two individuals in the panel do not seem to be acceptable.

According to the instruction 95 of the Secretariat Business Rules, if the Government desire not to accept the Commission's advice, as far as possible the Commission should be given a reasonable opportunity duly furnishing the reasons therefor, and its views thereon have to be obtained. But the views of the Commission was not obtained for eliminating their names before approving the panel. Whereas the Government in this regard have stated the procedure prescribed in Secretariat. Instruction 95 have been followed for deleting the names of the individuals.

In respect of Selvi. Doris Margaret Varadarajulu the Government even recommended for inclusion of her name in the panel for the year 2002-2003 and based on the same the Commission had also accorded its concurrence therefor in March 2006 itself. But the orders of the Government thereon are yet to be issued. Thus the Government have deviated from the recommendation of the Departmental Promotion Committee, in which the Secretary to Government Public Works Department was the Convenor and Member and took part in the deliberations.

By deviating from the Commission's views, the Government have deviated from the well – established convention that the Commission's views should always be accepted in all cases except in the case where policy is involved or where imperative reasons exist for not accepting the Commission's views.

C. The Government have violated their own instructions and the Commission trust that this will not recur in future. Details of the number of cases in which Government have not accepted the Commission's advice and the number of cases in which Government have not consulted the Commission are given for the last five years in Annexure – XII.

ACKNOWLEDGEMENT

The Commission records its appreciation for the co-operation extended by educational Institutions and their officers in the matter of providing suitable accommodation for conduct of examinations by the Commission.

The Commission is also grateful to the examiners and experts who, inspite of their personal inconvenience, readily accepted the Commission's invitation and assisted them in the conduct of different examinations and selection of officers to various posts under the State Government.

The Commission expresses its sincere thanks to all the Secretaries to Government and Heads of Departments for their kind co-operation in finalising the selection of candidates for appointment by recruitment by transfer/promotion through the Departmental Promotion Committees.

In conclusion, the Commission also places on record its appreciation of the Co-operation and efforts of the personnel in the smooth functioning of the Commission.

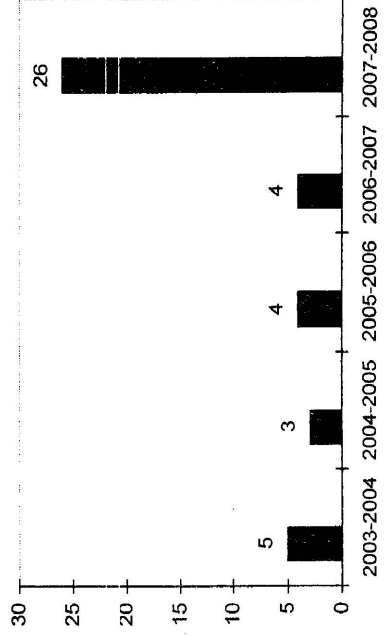

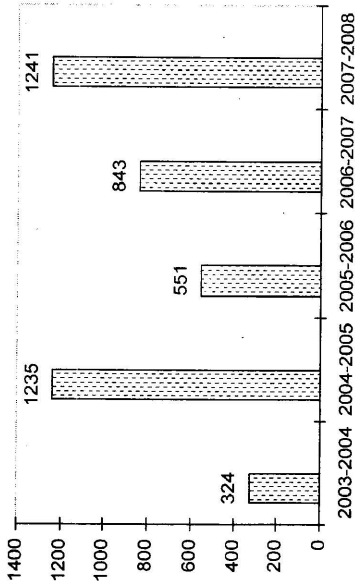


WRITTEN EXAMINATIONS CONDUCTED IN THE LAST FIVE YEARS PERIOD

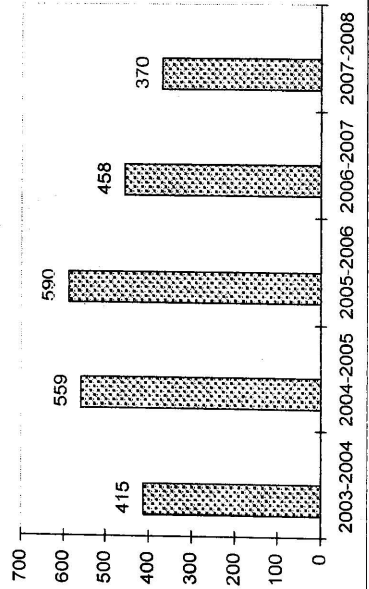

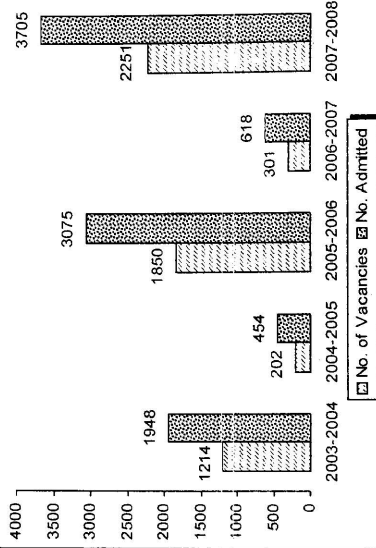
DETAILS OF DISCIPLINARY CASES DISPOSED IN THE LAST FIVE YEARS PERIOD
