FUNCTIONS AND DUTIES

The Tamil Nadu Public Service Commission is discharging the duties and functions specified in Article 320 of the Constitution of India. The Commission is required to advise the Government on all matters relating to framing of recruitment rules, principles to be followed in making appointments and promotions and transfers from one service to another service, disciplinary matters in respect of Government Servants. Tamil Nadu Public Service Commission conducts examinations for selection of candidates under direct recruitment to the State, Subordinate and Ministerial Services etc., Departmental Examinations for Government Servants, Half Yearly Examination for IAS, IPS, IFS and State Civil Service officers and also conducts the examination on behalf of the RIMC for admission to the School run by the Rashtriya Indian Military College, Dehra Dun.

8. Reforms and Rationalizations:-

Innovation introduced by the Commission in recent times

1. Annual Recruitment Planner:

The Commission releases the Annual Recruitment Planner every year in the month of January with an aim to provide information to the candidates about the conduct of current year recruitments. Details pertaining to various recruitment viz., name of examination, tentative date of notification, results etc., are mentioned in the Annual Recruitment Planner.

2. Online Application:

The Commission receives application through online from 2012 onwards. Online application has drastically reduced the time consumption taken in the conduct of examination process. The results are published at the earliest. Usage of Papers has almost been minimised.

3. Candidates' Dashboard:

As an advancement to the online application system, candidates' dashboard has been introduced. Candidates can register themselves in the One Time Registration and create their own dashboard. They can update their additional details whenever they wish.

4. Simple Payment Procedure:

Candidates have the option to pay their application fee and registration fee through Credit Card, Debit Card and Internet Banking. Candidates who do not have these facilities, can pay their fee through the Bank or Post Office Challan. Candidates can view their payment status in their Dashboard.

5. Special Software:

Commission has developed an exclusive tailor made software for pre and post examination data processing.

6. Videographing the activities in the Examination Hall:

All examination procedures conducted in the examination halls are videographed from the opening of question paper bundles till packing of used answer papers. Sensitive venues are monitored from the Commission's Office through webcasting.

Computer Based Test:

In order to speed up the recruitment selection process and publish the results at the earliest possible, the Commission has introduced Computer Based Test for almost all Technical posts examinations.

8. SMS and email:

Messages are sent to the candidates through SMS and emails, at the time of application registration, Certificate Verification, Oral Test and Counselling.

9. Publication of Answer Keys:

After the examination is over, the tentative answer keys are published in the Commission's Website. If candidates raise any objection on the answer keys published, the same is placed before the expert committee and final answer keys are arrived at and published in the Commission's website to establish the transparency in the examination procedure.

10. Certificate Uploading facility:

Candidates who are in the zone of consideration shall upload their certificate in the Commission's Website. The Certificates uploaded by the candidates are verified before the Oral Test or Counselling as the case may be.

11. Publication of Rank List and Cut off Marks:

Overall Rank List, Community wise Rank List and Special Category wise rank list are published at the end of every recruitment results. After the finalization of selection is over, cut off Marks is also published for each post.

12. Videographing Interview Boards:

All proceedings of Interview Boards are videographed.

13. Counselling:

Single Window system is followed for Counselling. Candidates are invited for counselling based on the marks. Candidates can choose the Department and the Post available during their turn. Vacancy positions are published at the end of the day in the Commission's Website.

14. Grievance Cell:

Grievance Redressal Cell is functioning in the Commission's Office with Toll Free Telephone Connections (Toll Free No. 1800 425 1002). Candidates can approach the Grievance Redressal Cell by Phone, email or in person for their redressal.

PART - II

DIRECT RECRUITMENTS:

During the period under report, the Commission completely finalized 23 recruitments containing 15904 vacancies and selected 15682 candidates for appointments. The recruitment statistics in respect of 23 selections are given in Annexure - III.

PRELIMINARY EXAMINATION:

During the period under report, the Commission conducted one Preliminary examination for Group-I Services to fill up 79 Vacancies. 1,63,651 Candidates applied for this Preliminary Examination.

MAIN EXAMINATION:

During the period under report, the Commission conducted 13 Main Examinations to fill up 10,595 vacancies. 30,16,201 candidates applied for these Main Examinations.

ORAL EXAMINATION:

During the period under report, the Commission conducted Oral Test for 20 Recruitments to fill up 728 vacancies. The Commission conducted the Oral Tests in 27 working days in two sessions (F.N. and A.N). A maximum of 6 Boards were constituted in both the sessions on some days, 1439 candidates were admitted to Oral Test by constituting 226 oral test boards in 27 days for the current year.

Paucity of Qualified and Suitable candidates:-

During the period under report, the following 140 vacancies could not be filled up due to paucity of qualified and suitable candidates:-

Combined Subordinate Services Examination - I 2009-11 (OT Post) 32, Combined Subordinate Services Examination -I 2009-11 (Non -OT) 9, Combined Subordinate Services Examination -I, 2011-13 (OT) - 9, Assistant in Secretariat Group V - A (Recruitment by Transfer) - 27, Group IV (2013-14) Typist -17, Steno Typist- 32, Assistant Statistical Investigator (2009-11) - 2, Curator- 1, Assistant Curator - 1, Executive Officer Grade - I - 1, Assistant Public Prosecutor Grade - II - 3, Assistant Medical Officer (Unani) - 5 and Scientific Assistant Grade -II - 1. 3. STATUTORY RULES, REGULATION, ETC.:

In 1000 cases, the Commission's concurrence was sought for and given under the latter part of Regulation 16(b) of the Tamil Nadu Public Service Commission Regulations 1954 for making appointment to the posts in the State, Subordinate, Secretariat and Ministerial Services.

5. CONCURRENCE ACCORDED UNDER RULE 20(a) (iii) OF THE SPECIAL RULES FOR THE TAMIL NADU MINISTERIAL SERVICE:

The Commission accorded its concurrence under the provision in Rule 20(a)(iii) of the Special Rules of Tamil Nadu Ministerial Services for the permanent transfer of 132 personnel from one departmental unit to another departmental unit within the Tamil Nadu Ministerial Service and in two cases, consent were refused.

6. PROMULGATION AND AMENDMENTS:

During the period under report, 40 cases of issue of statutory rules or amendments were issued by the Government. Of them, in respect of 32 cases, the Commission was consulted before the rules were issued. In 8 cases the Commission was not consulted. However, these 8 cases relate to the posts excluded from the purview of the Commission and to the matter, in respect of which under Article 320(3) of the Constitution of India, consultation with Commission is not necessary.

7. RELAXATION OF RULE:

During the period under report, there were 20 cases in which statutory rules relating to age or educational qualifications as the case may be, were relaxed by the Government.

PART-V

OTHER EXAMINATIONS

I. DEPARTMENTAL EXAMINATIONS:

Departmental Tests were conducted in May and December 2014. The total number of tests conducted were 331 and the number of candidates applied for these tests were 2,22,432. The details are given below:-

II. HALF YEARLY EXAMINATIONS:

Half Yearly Examinations including First Class Language Test in Tamil were conducted in September 2014 and March 2015 respectively for Officers of Indian Administrative Service, Indian Police Service, Indian Forest Service and State services, in which 90 and 81 candidates were admitted respectively.

III. EXAMINATION FOR ADMISSION TO RASHTRIYA INDIAN MILITARY COLLEGE SCHOOL:-

The Commission conducted the Examination on behalf of the Rashtriya Indian Military College in June 2014 and in December 2014 for selection of candidates for admission to the Rashtriya Indian Military College School, Dehra Dun. 81 Students in June and 80 Students in December appeared for the examination.

PART- VI

GOVERNMENT AND THE COMMISSION

A. DEVIATIONS OF GOVERNMENT FROM COMMISSION'S ADVICE:

During the period under report, the Government have deviated from the Commission's advice and issued order in two cases. The details are as follows:-

Case-1

G.O(D)No.460, Public Works Department (C2), dated 04.11.2013

The Government arrived at a provisional conclusion to impose a punishment of cut in pension at the rate of Rs. 2450/- per month on the delinquent officer Thiru. N. Soman, Supenintending Engineer (Retired), Public Works Department Permanently. The delinquent Officer has not accepted the proposed punishment of the Government. The Government have sought the views of the Commission.

The Commission communicated its views in letter dated 12.02.2013 to the Government stating that the provisional conclusion arrived at by the Government to impose a punishment of cut in pension at the rate of Rs. 2,450/- per month permanently appears to be on the higher side and hence it advised the Government to modify the punishment into that of cut in pension of Rs. 2,450/- per month for 8 years.

The Government issued orders in G.O.(D) No. 460, Public Works Department (C2), dated 04.11.2013, deviating from the Commission's views have imposed the proposed punishment of cut in pension of Rs. 2450/- permanently on the delinquent Officer stating that the Commission has not adduced any reason as to why the proposed punishment of the Government is found to be on the higher side.

Thus the Government have issued orders deviating from the Commission's views.

Case-2

G.O.(2D)No.24, School Education (H.E.K1) Department, Dated 27.06.2012

The Government sought the views of the Commission on the review petition preferred by Thiru. D. Murugadoss, formerely Headmaster, Municipal Girls Higher Secondary School, Kallanai, Tirunelveli District against the punishment of stoppage of increment for two years with cumulative effect imposed on him.

The Commission communicated its views dated 07.02.2012 to the Government to set aside the defective final orders and then to communicate the reason for deviation from the findings of the inquiry Officer in respect of charge I and thereafter to pass final orders after obtaining further representation from the review petitioner.

The Government issued orders in G.O.(2D) No.24, School Education (H.E.K1) Department, dated 27.06.2012 by allowing the review petition and cancelling the punishment of stoppage of increment for two years with cumulative effect, stating the reason that the charges were proved against the review petitioner based on preponderance of probability and in view of his services rendered enabling his school student to obtain first rank in the State.

The Government issued orders deviating from the Commission's views.

B. Non-consultation with the Commission:

C. The Government have deviated from the views of the Commission, except to uphold the policy decisions of the Government and in unforeseen circumstances and the Commission trusts that this will not recur in future. Details of the number of cases in which Government have not accepted the Commission's advice and the number of cases in which Government have not consulted the Commission for the last five years are given in Annexure – XI.

The Commission records its appreciation for the co-operation extended by Educational Institutions and their officers in the matter of providing suitable accommodation for conduct of examinations by the Commission.

The Commission is also grateful to the Examiners and Experts who, in spite of their personal inconvenience, readily accepted the Commission's invitation and gave assistance in the conduct of different examinations and selection of officers to various posts under the State Government.

The Commission expresses its sincere thanks to all the Secretaries to Government and Heads of Departments for their kind co-operation in finalizing the selection of candidates for appointment by recruitment by transfer/promotion through the Departmental Promotion Committees.

In conclusion, the Commission also records its appreciation for the Co-operation and efforts of all the staff Members in the smooth functioning of the Commission.





MEMORANDUM EXPLAINING THE REASONS FOR DEVIATION FROM THE ADVICE OF TAMIL NADU PUBLIC SERVICE COMMISSION IN TWO CASES REFERRED TO IN PART VI OF THE ANNUAL REPORT OF THE TAMIL NADU PUBLIC SERVICE COMMISSION FOR THE YEAR 2014-2015.

### Case-I

The Director of Fisheries brought to the notice of the Government that Thiru. N. Soman, during his tenure as Superintending Engineer, Fishing Harbour Project Circle, Chennai from 19.06.1997 to 28.02.1999 had resorted to purchase of cement and steel from the private contractors for Nagercoil and Thanjavur Divisions instead of from Tamil Nadu Cements Corporation Limited (TANCEM) in violation of Government orders for the construction of free houses for fishermen and caused huge financial loss to the Government. Therefore, departmental disciplinary action under Rule 9(2)(b)(ii) of the Tamil Nadu Pension Rules, 1978, was initiated against him by framing five specific charges. The completion of the process of the inquiry led the charges to be held as proved. After following all the procedures enshrined in the Tamil Nadu Pension Rules, 1978, the Public Works Department held all the charges against the individual as proved and arrived at a provisional conclusion to impose the punishment of withholding of pension at the rate of Rs.2,450/- (Rupees two thousand four hundred and fifty only) per mensem permanently on Thiru. N. Soman, Superintending Engineer (Retired). In this regard, a show cause notice under Tamil Nadu Pension Rules, 1978, was issued to the delinquent officer calling for his willingness or otherwise on the said provisional conclusion. Thiru N. Soman, Superintending Engineer (Retired) submitted his representation stating that he did not accept the punishment proposed by the Government. Therefore, the views of Tamil Nadu Public Service Commission under Regulation 18(1)(c) of the Tamil Nadu Public Service Commission Regulations, 1954, were called for.

- The Tamil Nadu Public Service Commission had, in its views stated as follows:-
- "...Despite the fact that all the charges are proved to establish his delinquency, the provisional conclusion arrived at by the Government to impose a punishment of cut in pension at the rate of Rs.2,450/- per month permanently appears to be on the higher side. Hence, the Commission advises that the punishment be modified as a cut in pension of Rs.2,450/- per month for 8 years and the Government may be informed accordingly."
- 3. The Public Works Department, after examining the views of the Tamil Nadu Public Service Commission, decided to deviate from its views, stating that the punishment proposed to be imposed on the delinquent officer was not on the higher side and was commensurate with the charges and that the Commission had also not stated why the punishment was found to be on the higher side. The Government, therefore, in deviation from the views of the Tamil Nadu Public Service Commission, confirmed its provisional conclusion and imposed the punishment of withholding of pension at the rate of Rs.2,450/- (Rupees Two thousand four hundred and fifty only) per mensem permanently in G.O.(D).No. 460, Public Works (E2) Department, dated 04.11.2013 on Thiru. N. Soman, Superintending Engineer (Retired).

### Case-II

Disciplinary action under rule 17(b) of Tamil Nadu Civil Services (Discipline and Appeal) Rules was initiated by the Director of School Education against Thiru. D.Murugadoss, formerly Headmaster, Kallanai Municipal (Girls) Higher Secondary School, Tirunelveli District regarding acceptance of bribe, misappropriation of funds in supply of cost free text books and notebooks and payment of scholarship amount to students while he was serving as Headmaster.

- 2. Final orders were issued vide G.O. (Ms.) No.216, School Education (HS1) Department, dated 07.11.2008, imposing a punishment of stoppage of increment for two years with cumulative effect for the proved charges. Aggrieved by this, Thiru D. Murugadoss submitted Review petition dated 16.03.2009. The views of the Tamil Nadu Public Service Commission was sought for on the Review petition of the petitioner under Regulation 18(1)(a) of the Tamil Nadu Public Service Commission Regulations, 1954.
  - 3. The Tamil Nadu Public Service Commission offered the following views:-

In this case five Charges were framed against the Review petitioner Thiru D. Murugadoss, formerly Headmaster, Kallanai Municipal (Girls) Higher Secondary School, Tirunelveli District (Charge No.1 and 2, Additional Charge No.1 and Second Additional Charge No.1 and 2). In the enquiry report, the inquiry officer has stated that Charge No.1 cannot be confirmed, nothing could be stated on the genuineness of the Charge No.2 and the Additional Charge No.1 of the first additional charge and Charge No.1 and 2 of the Second Additional Charge were held proved. After obtaining the further representation from the Review petitioner on the

enquiry report, it was decided by the Government that among the five charges against him Charge No.2 was not held proved and the remaining charges were held proved and imposed the punishment of stoppage of increment for 2 years with cumulative effect. The Tamil Nadu Public Service Commission has opined that regarding Charge No.1 since the inquiry officer has stated that the Charge was not confirmed (i.e.) proved, the Government should have passed final orders after obtaining the further representation of the Review petitioner by communicating the reasons for deviation from the enquiry report in respect of Charge No.1. Instead, further representation was called for by the Government by merely sending the enquiry report to the review petitioner. Hence there is a flaw in the decision and the final orders issued imposing punishment is not in accordance with rule provision. Hence the final orders of the Government have to be set aside. The Tamil Nadu Public Service Commission has therefore advised the Government to cancel the final orders and to finalise the case and pass final orders after obtaining the further representation of the Review petitioner in respect of the Charge No.1 duly stating the reasons for deviation from the report of the enquiry officer in respect of Charge No.1.

4. The Government, after careful consideration of the views of the Tamil Nadu Public Service Commission and the related records, and also considering his dedicated service in coaching the students to get State ranks, decided to deviate from the views of the Tamil Nadu Public Service Commission and orders were issued on the Review petition vide G.O.(2D)No.24, School Education (HS1) Department, dated 27.06.2012 cancelling the punishment already imposed on Thiru D. Murugadoss, formerly Headmaster.
