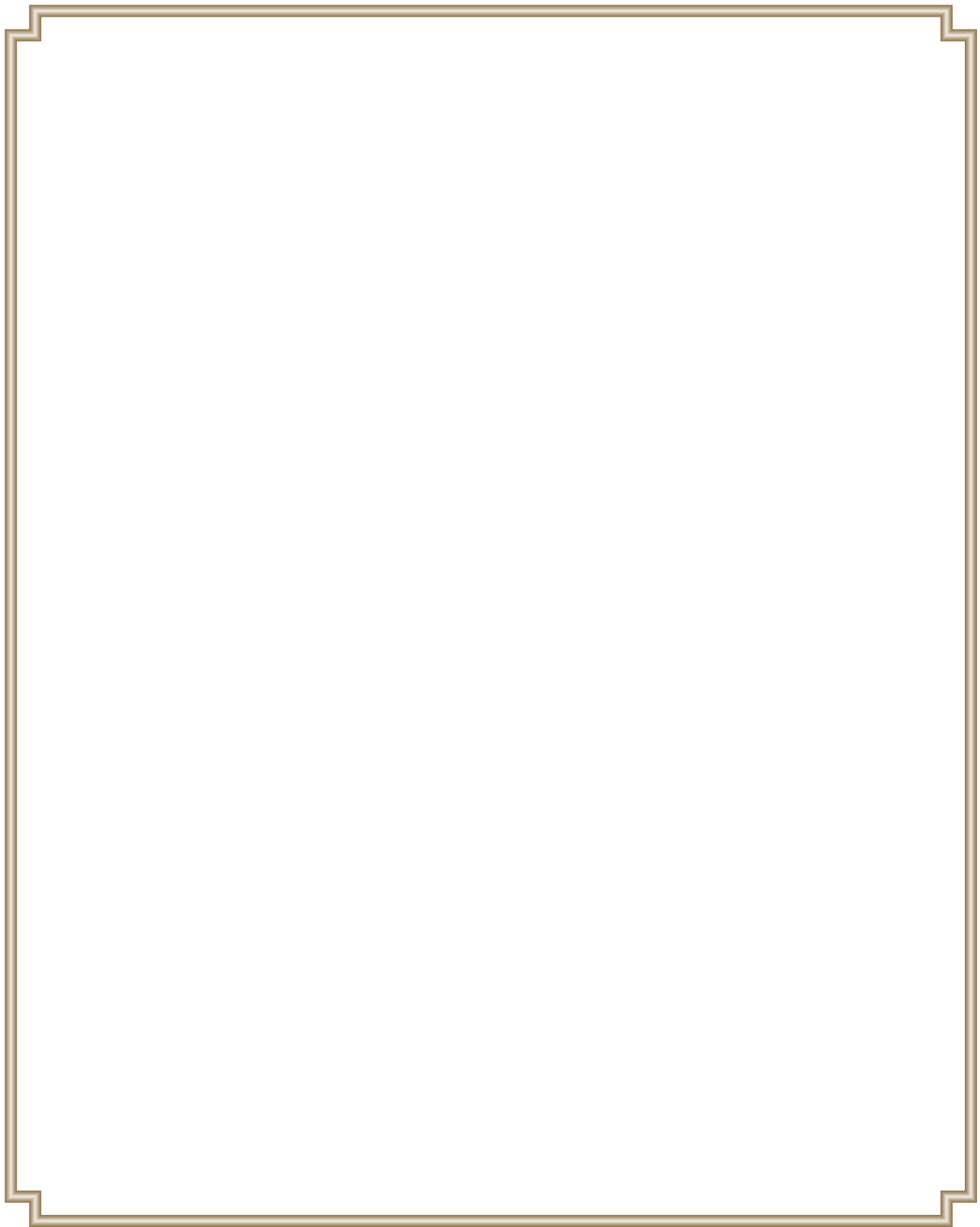

The Tamil Nadu Public Service Commission has been set up under Article 315 of the Constitution of India. The sanctioned strength of the Commission is one Chairman and fourteen Members. PART – I

FUNCTIONS AND DUTIES

The Tamil Nadu Public Service Commission is discharging the duties and functions specified in Article 320 of the Constitution of India. The Commission is required to advise the Government on all matters relating to framing of recruitment rules, principles to be followed in making appointments and promotions and transfers from one service to another service, disciplinary matters in respect of Government Servants. Tamil Nadu Public Service Commission conducts examinations for selection of candidates under direct recruitment to the State, Subordinate and Ministerial Services etc., Departmental Examinations for Government Servants, Half Yearly Examination for IAS, IPS, IFS and State Civil Service officers, conducts the examination on behalf of the RIMC for admission to the School run by the Rashtriya Indian Military College, Dehradun and also conducts Examinations for the recruitments of High Court Services etc.,

(E) Notifications :

2023536 applications were received for 12095 vacancies in respect of 45 posts advertised in 18 Notifications. (Details in Annexure-IV)

(F) Reforms and Rationalizations :

(i) Enhanced Dashboard to the candidates with additional facilities : Candidates' Personalized Dashboard with unique login ID and password for each candidate is introduced for One Time Registration. As an added feature in the Dash Board, application history containing the details of previous successful applications submitted by the candidates has been introduced. This feature facilitates the candidates to know about the previous application details viz., Notification number, Name of the post applied for, Register number, Application number., Date of application etc., Candidates who have lost their application number or register numbers of any recruitment conducted since 2012, can view their details at 24x7 from the Commission's Website. We have reached the candidates to facilitate, instead of asking them to reach us.

(ii) Syllabus :

The syllabi framed long back in the year 2000 for Commission's competitive examinations for Diploma, Graduate and Post Graduate levels are updated and revised for various subjects during this period.

(iii) Instructions to Applicants :

Instructions to Applicants are updated and hosted in the Commission's website during this period (w.e.f 24.03.2020)

(iv) Online Certificate Verification :

The Commission has introduced a new system of obtaining the scanned copy of the original certificates of the shortlisted candidates through online mode. Candidates have to scan and upload their certificates so as to substantiate their claims made in the online application. After due date, the Commission will verify the certificates and call only qualified candidates possessing all certificates as per their claim in the online application. In this new process Original Certificates will be verified at the time of Oral Test/Counseling for which the candidates have to appear in person. The task of scanning and uploading activity has been entrusted to the Arasu e-Seva Centers which are run by TACTV (Tamil Nadu Arasu Cable TV) in all Taluk and District Headquarters. Certificates uploaded through online mode are being verified onscreen so as to finalise the candidate's status very quickly without the hard copies of certificates. In this process no papers are used keeping in mind the environmental concern.

(v) Grouping of Examinations :

Commission has implemented grouping of examinations like Group-IV services Examination (JA, VAO etc.), Combined Engineering Services Examination for Direct Recruitment to save time factors, money and for convenience of candidates in a cost efficient manner and to disseminate results within a short span of time.

(vi) Personalized OMR :

Commission has introduced Personalized OMR in all Objective type Examinations with the details of Candidate's Name, Photograph, Register Number, Name of the Optional Subject and Venue details. Personalized OMR Answer Sheet was also introduced for descriptive type of examination in the Departmental Test Examination in May'2019. Candidates can write the examination using his personalized OMR answer sheet in the allotted exam centre only. Register Number error does not arise in this type of usage.

(viii) Installation of CCTV in Confidential wings :

CCTV cameras are installed in the Confidential wings & Counseling Hall under the control of Controller of Examinations. All the activities are monitored by the Controller of Examinations .

(ix) Short film – Information & Instruction to the candidates:

Short film regarding information and instructions to the candidates were released. It is very useful to the candidates and more than 1 Lakh candidates have viewed so far. It is pointed out that no other Public Service Commission has released the short-film in detailed manner as done by Tamil Nadu Public Service Commission.

(x) Tentative Date of Publication of results:

To set a time line for TNPSC and also as an information to the candidates, the tentative date of publication of results are hosted in the Commission's Website

(xi) Reforms in Oral Test (Token System):

Before commencement of Oral Test, candidates are at their liberty to choose their Interview Boards by picking out the Tokens.

(xii) Reforms in result process :

High technology is used for processing the results quickly.

(xiii) E-Mail and SMS Services :

Information regarding Certificate verification, Oral Test and Counselling are being sent through E-mail and SMS so as to finalize the selection process promptly without any delay.

(xiv) Counselling :

A Counselling Hall with all amenities is functioning in the Commission's office for the benefit of the candidates. Commission issues allotment order to the candidates who select their Department/Unit on the same day of counseling.

PART – II

DIRECT RECRUITMENTS

During the period under report, the Commission completely finalized 44 recruitments containing 9739 vacancies and selected 9480 candidates for appointments. The recruitment statistics in respect of 44 selections are given in Annexure - III.

1. PRELIMINARY EXAMINATION:-

During the period under report, the Commission conducted one Preliminary examination for the Civil Judges in the Tamil Nadu State Judicial Service, to fill up 176 Vacancies. 8691 candidates applied for this Preliminary Examination.

2. MAIN EXAMINATION:-

During the period under report, the Commission conducted 28 Main Examinations to fill up 12777 vacancies. 1848704 candidates applied for these Main Examinations.

3. ORAL EXAMINATION:-

During the period under report, the Commission conducted Oral Test for 37 Recruitments to fill up 3149 vacancies. The Commission conducted the Oral Tests in 87 working days in two sessions F.N. and A.N. A maximum of 5 Boards were constituted in both the sessions on some days, 6246 candidates were admitted to Oral Test by constituting 538 oral test boards in 87 days for the current year.

PAUCITY OF QUALIFIED AND SUITABLE CANDIDATES

During the period under report, 38 vacancies were not filled up due to paucity of qualified and suitable candidates.

1. RECRUITMENT BY TRANSFER / PROMOTION:-

During the period under report, the Commission dealt with references relating to recruitment by transfer to State Services from the corresponding Subordinate Services and by promotions within the State Services and drew up lists of 897 qualified and suitable officials for appointment to the 47 posts under various Services. During the period under report, there were 13 cases in which statutory rules relating to age or educational qualifications as the case may be, were relaxed by the Government. Details are furnished in Annexure-VII.

3. CONCURRENCE ACCORDED UNDER RULE 20(a)(iii) OF THE SPECIAL RULES FOR THE TAMIL NADU MINISTERIAL SERVICE :-

The Commission accorded its concurrence under the provision in Rule 20(a)(iii) of the Special Rules of Tamil Nadu Ministerial Services for the permanent transfer of 93 personnel from one departmental unit to another departmental unit within the Tamil Nadu Ministerial Service.

4. 10% AND 20 % RESERVATION :-

The Commission had accorded its concurrence for 148 persons under the latter part of the Regulation 16(b) of the Tamil Nadu Public Service Commission Regulations, 1954, for the period from 01.04.2019 to 31.03.2020.

5. STATUTORY RULES, REGULATIONS, ETC.:-

In 50 cases, the Commission's concurrence was sought for and given under the latter part of Regulation 16(b) of the Tamil Nadu Public Service Commission Regulations, 1954 for making appointment to the posts in the State, Subordinate, Secretariat and Ministerial Services.

Details of the posts and services for which such concurrence was accorded are given in Annexure-IX.

6. TEMPORARY APPOINTMENTS:-

The Commission has not accorded its concurrence for the continuance of temporary appointment as no such cases received.

2. HALF YEARLY EXAMINATIONS :-

Half Yearly Examinations including First Class Language Test in Tamil were conducted in April and November / December 2019 for Officers of Indian Administrative Service, Indian Police Service, Indian Forest Service and State Services, in which 79 and 61 candidates were admitted respectively.

3. EXAMINATION FOR ADMISSION TO RASHTRIYA INDIAN MILITARY COLLEGE SCHOOL :-

The Commission conducted the Examination on behalf of the Rashtriya Indian Military College in June 2019 and in December 2019 for selection of candidates for admission to the Rashtriya Indian Military College School, Dehradun. 87 Students in June and 147 Students in December appeared for the examination.

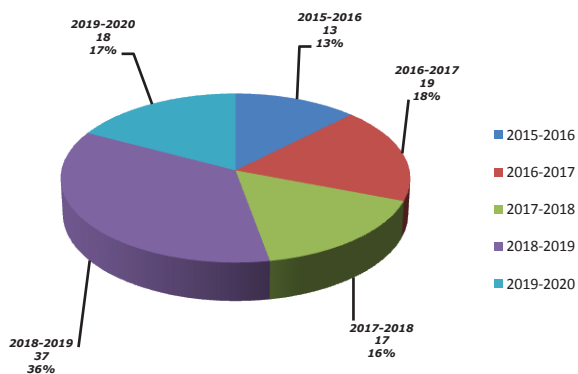

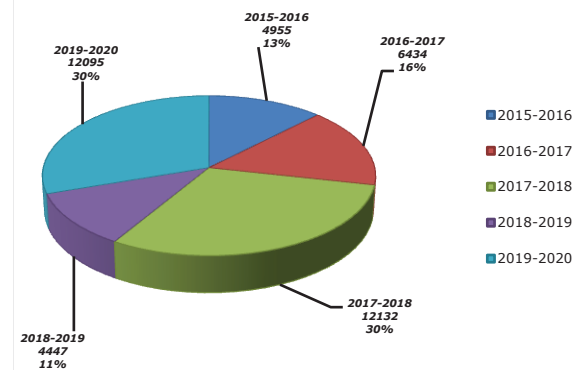

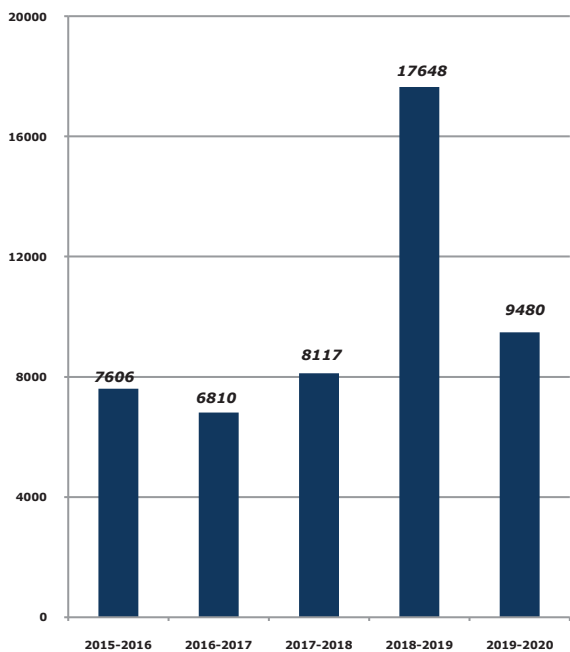

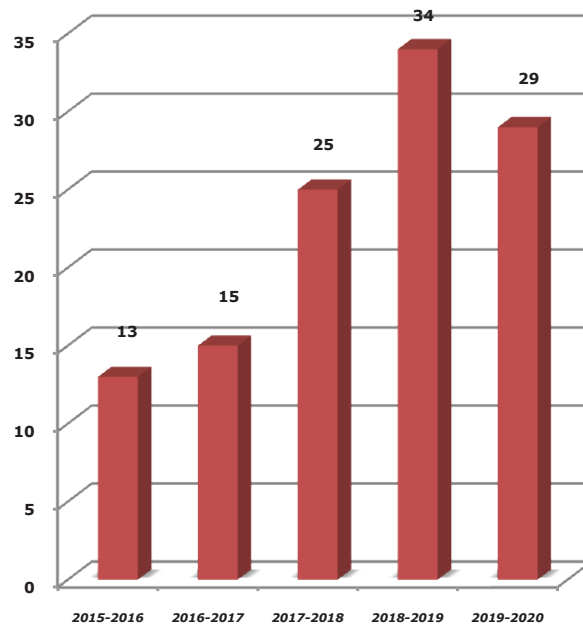

Number of candidates selected and recommended for appointments in the last five years

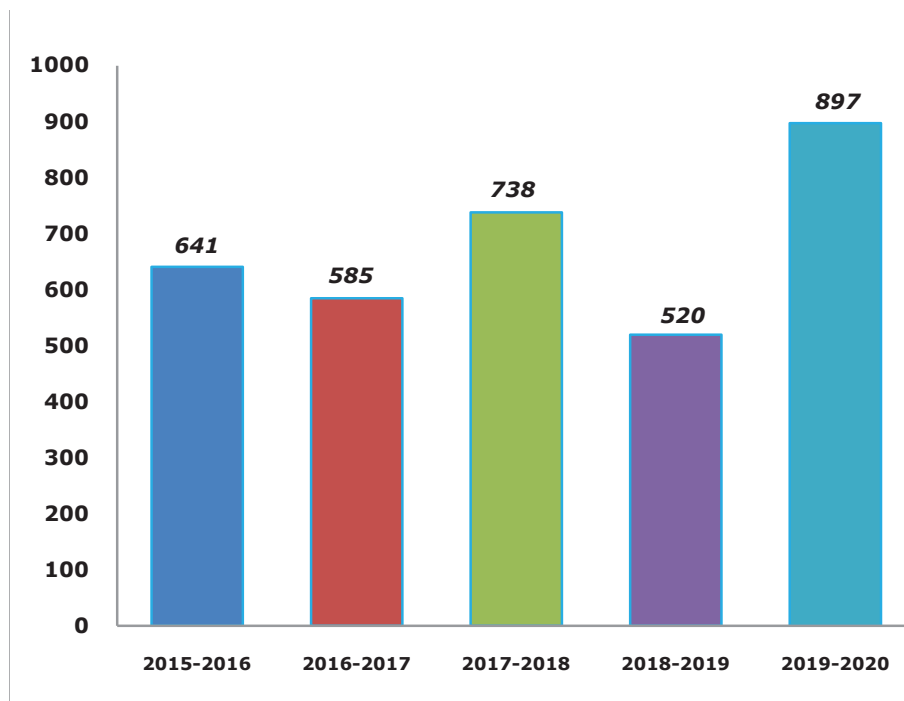


Written Examinations conducted in the last five years

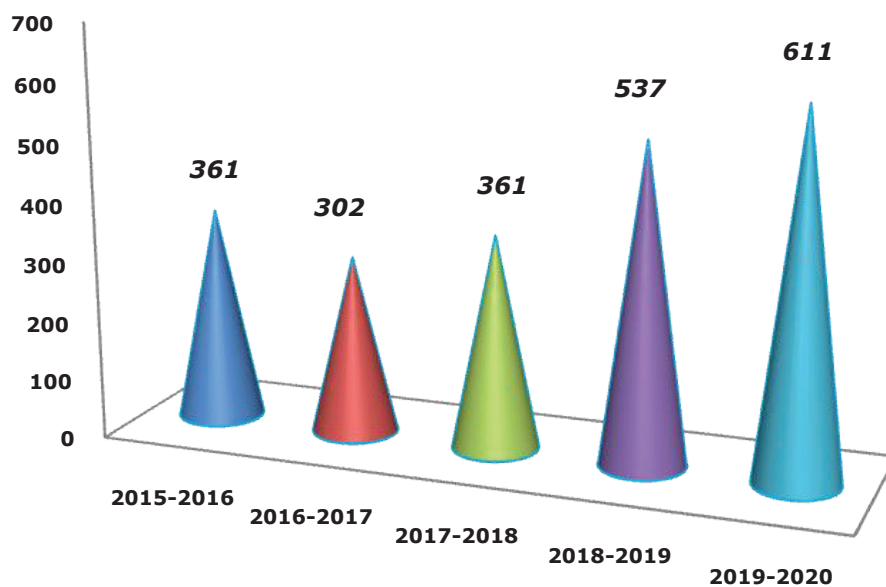

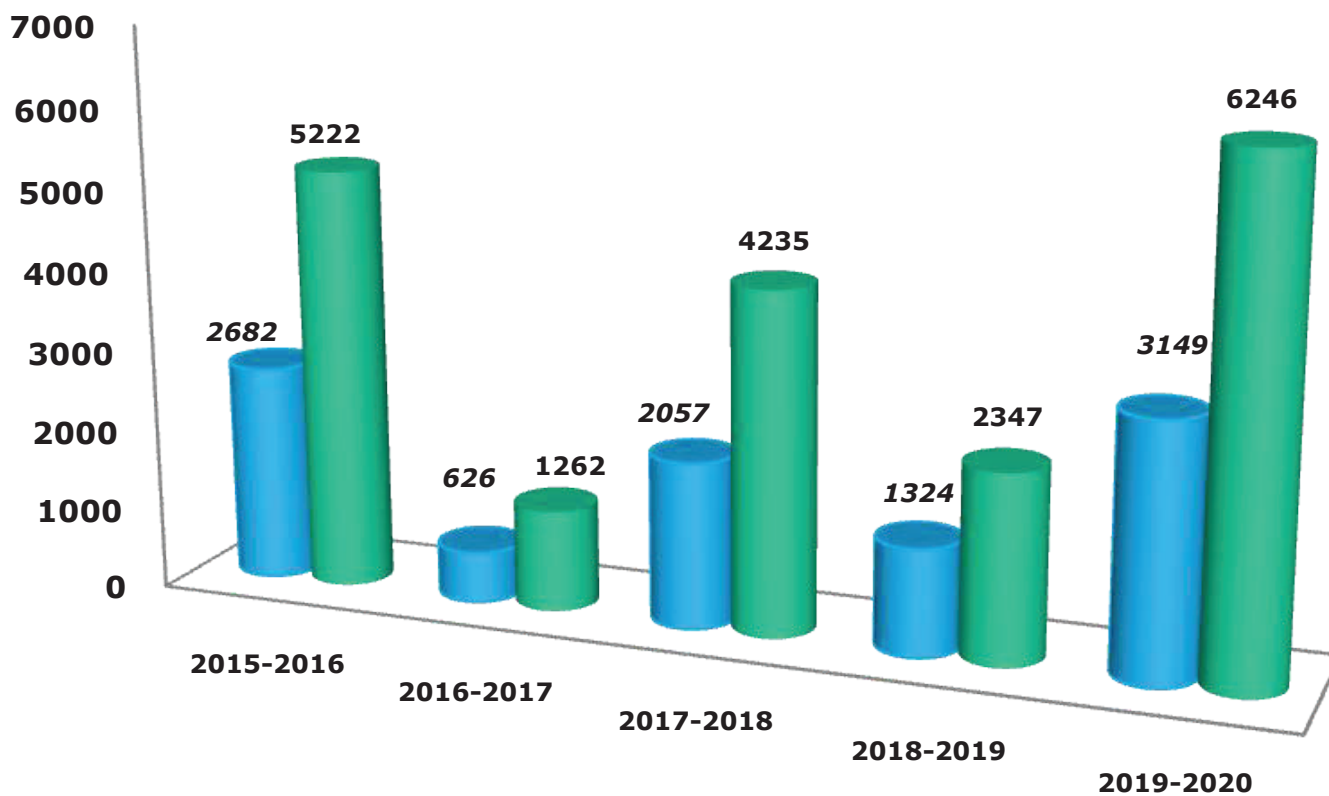
Number of Candidates recommended for Appointment by Recruitment through Transfer / Promotion in the last Five Years



**MEMORANDUM EXPLAINING THE REASONS FOR DEVIATION FROM THE
ADVICE OF TAMIL NADU PUBLIC SERVICE COMMISSION IN THREE CASES
REFERRED TO IN PART VI OF THE ANNUAL REPORT OF THE TAMIL NADU
PUBLIC SERVICE COMMISSION FOR THE YEAR 2019-2020**

Case:1

G.O.(D) No.400, Rural Development and Panchayat Raj (E3) Department, dated 04.10.2018.

In this case Disciplinary action was initiated under Rule 17(a) of Tamil Nadu Civil Services (Discipline and Appeal) Rules, against Thiru.K.Rajaraman, Assistant Executive Engineer (RD) 2006-2007, Anna Renaissance Plan under Lalgudi (NABARD) Panchayat, for having failed to monitor the progress of the Anna Grama Marumalarchi Scheme works in Lalgudi Panchayat Union, Trichy District and delayed the completion of work within the specified period. The Commissioner, Rural Development and Panchayat Raj Department, had issued final orders by imposing a punishment of "Stoppage of increment for three months without cumulative effect". Against the above punishment, the appellant has preferred an appeal to the Government and the Government have sought the views of the Commission under regulation 18(1)(a) of the Tamil Nadu Public Service Commission Regulations, 1954.

2. The Commission after examining the case carefully had advised the Government to Relax the imposed punishment of "Stoppage of increment for three months without cumulative effect" on the appellant and recommended to impose the punishment of "Censure " to him.

3. But, the Government have deviated from the views of the Commission and dropped the imposed punishment of "Stoppage of increment for three months without cumulative effect" to the appellant and issued necessary orders.

4. Thus the Government have issued orders by deviating from the Commission's views on the appeal against Thiru.K.Rajaraman, Assistant Executive Engineer (RD).

Reason for Deviation

The petitioner submitted a petition on 09.07.2018 to Government and a personal hearing was offered to him by the Additional Chief Secretary to Government, Rural Development and Panchayat Raj Department on 01.08.2018. During the personal hearing the petitioner adduced new grounds to defend him. After analysing the deposition of the appellant during the personal hearing it was concluded that there was no possibility of completing the work as stated in the charge memo.

2. Therefore, the Government decided to deviate from the views of the Tamil Nadu Public Service Commission and drop the Punishment of "Stoppage of increment for three months without cumulative effect" imposed to the appellant by the Commissioner of Rural Development and Panchayat Raj and issued necessary orders. Thus the Government have issued orders by deviating from the Commission's views on the appeal against Thiru.K.Rajaraman, Assistant Executive Engineer (RD).

CASE :2

1. G.O. (3D) No.30, Agriculture (AA,5) Department, dated 14.02.2011.
2. G.O. (3D) No.31, Agriculture (AA,5) Department, dated 14.02.2011.
3. G.O. (3D) No.32, Agriculture (AA,5) Department, dated 14.02.2011.

Disciplinary action under rule 17(b) of Tamil Nadu Civil Services (Discipline and Appeal) Rules was taken against Tvl.Sampath, M.Premkumar and P.Palanichamy, Agriculture Officers, for causing pecuniary loss of Rs.2,25,943/- in not curtailing crop disease to 47,386 coconut seedling in Government coconut seeding Nursery, Vaigai Dam, Madurai District during 1984-1987. The Government arrived at a provisional conclusion to impose the punishment of stoppage of increment for 18 months without cumulative effect and recovered the amount which was pecuniary loss to the Government from them and sought the views of the Commission under Regulation 18(1)(b)(ii) of the Tamil Nadu Public Service Commission Regulations, 1954.

2. The Commission offered the following views:-

In this disciplinary case, the TNPSC stated that the 3 officers have been accused of not curtailing crop disease in the coconuts trees 7 or 8 months after their transfer. Therefore, the Commission advised the Government to drop the proposed punishment on the three Delinquent Officers and to relieve from the charges framed against them.

3. But, the Government deviated from the views of the Commission and confirmed the provisional decision imposing the punishment of "Stoppage of increment for 18 months without cumulative effect and pecuniary loss to the Government caused by them and shall be recovered from them" as stated in the proposal and issued necessary orders to the said effect.

4. Thus the Government have issued orders by deviating from the Commission's views on the disciplinary action initiated against Tvl.M.Sampath, M.Premkumar and P.Palanichamy, Agriculture Officers.

Reason for Deviation

As the Tamil Nadu Public Service Commission did not find any defect in the disciplinary proceedings and as the Enquiry Officer has not mentioned that there was no evidence to prove the charge, the views of the Tamil Nadu Public Service Commission was deviated and the proposed punishment was confirmed. Accordingly, deviating from the views of the TNPSC, orders were issued by the Government in G.O.(D).Nos.31,32,33, Agriculture (AA5) Department, dated 14.02.2011, imposing the punishment of stoppage of increment for 18 months without Cumulative Effect, besides, the recovery of the Government loss caused by the delinquent officers.

CASE :3

1. G.O. (2D) No.14, Finance (Treasuries & Accounts) Department, dated 06.05.2019.
2. G.O. (2D) No.15, Finance (Treasuries & Accounts) Department, dated 06.05.2019.

In this case, the Government have forwarded records relating to the Disciplinary Case initiated against Thiru.V.Subramani, Assistant Treasury Officer (Under Suspension) and Tmt.V.Indhumathi, Additional Sub-Treasury Officer (Under Suspension) under rule 17(b) of Tamil Nadu Civil Services (Discipline & Appeal)

Rules for misappropriation of Government money and have sought the views of the Commission on the proposed punishment of "Removal from Service" under Regulation 18(1)(b)(iv) of Tamil Nadu Public Service Commission Regulations, 1954.

2. The Commission after examining the case carefully advised the Government as follows:-

The Commission is of opinion that in order to comply the principles of natural justice, the inquiry is to be conducted once again by supplying the documents requested by them and the copy of documents relating to the deposition made in criminal case. Hence, the Commission advises the Government that the above said documents have to be submitted to the Delinquent Officers for their perusal and re-enquiry has to be conducted. On the basis of the fresh enquiry report, the case has to be proceeded further.

3. But the Government in G.O. (2D) No.14 & 15, Finance (Treasuries & Accounts-1) Department, dated 06.05.2019 have issued orders by deviating from the Commission's views on the Disciplinary Action initiated against Thiru.V.Subramani, Assistant Treasury Officer (Under Suspension) and Tmt.V.Indhumathi, Additional Sub-Treasury Officer (Under Suspension).

Reason for Deviation

In this case the charges have been framed against both of the delinquent officers based on clear evidence and they were allowed to peruse all the connected records and detailed inquiry was conducted after giving full opportunity to put forth their defence and after consideration of their explanation and after through examination, all the charges framed against them were held proved. Consequently it was decided to impose the punishment of "Removal from Service" on Thiru.V.Subramani, Assistant Treasury Officer (Under Suspension) for the proven charges and Tmt. V.Indumathi, Additional Sub-Treasury Officer (Under Suspension). At this stage, conducting re-inquiry as opined by the Commission will enable them to destruct and tamper with the remaining records as the Delinquent Officers had already tampered the records and the records in the computers. Hence, the Government had decided to confirm the provisional punishment of "Removal from Service" to Thiru.V.Subramani, Assistant Treasury Officer (Under Suspension) and Tmt. V.Indumathi, Additional Sub-Treasury Officer (Under Suspension) and issued orders accordingly vide G.O(2D) No.14 & 15, Finance(T&A-I) Department, Dated 06.05.2019 in deviation of Commission's views.
