**ORDER:-**

Based on the resolutions passed in the 27<sup>th</sup> and 28<sup>th</sup> Equivalence Committee meeting held on 13.09.2024 and 25.09.2024 respectively, under the Chairmanship of the Additional Chief Secretary to Government, Higher Education Department, on the equivalence / non-equivalence of degrees offered by various Universities / Educational Institutions to the similar degrees, the Government have concurred with the aforesaid views of the Subject Expert Committee / Equivalence Committee and accordingly issued orders in the reference third and fourth read above. In the above said Two Government Orders, among other things, in respect of item No:35 and item No:4, it has been ordered as follows :-

2. The Member-Secretary i/c, Tamil Nadu State Council for Higher Education in the letter fifth read above among other things has stated that the recommendations of the High Level Domain Expert Committee was placed in the 27<sup>th</sup> Equivalence Committee Meeting. Based on the resolutions passed in the 27<sup>th</sup> Equivalence Committee Meeting, the Government have issued G.O. (Ms) No.170 Higher Education (K1) Department, dated 24.09.2024 stating that B.Com., (Accounting and Finance) offered by Women's Christian College affiliated to University of Madras is "Not Equivalent" to B.Com., for the purpose of Higher Studies, wherein the year of syllabus compared by the Chairpersons, BoS was not mentioned in the Government Order.

3. The Member-Secretary i/c, Tamil Nadu State Council for Higher Education has therefore requested the Government to issue necessary amendment by incorporating the year to the orders issued in Government Order third read above, as was mentioned in the Government Order fourth read above.


