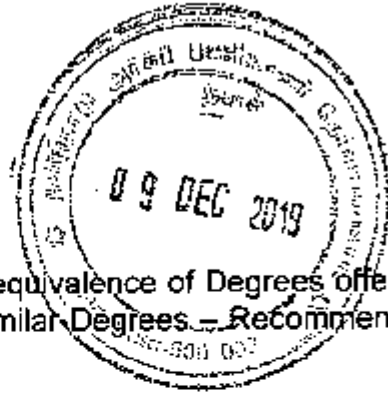

ORDER:-

In the letter second read above, the Chairman, Equivalence Committee / Principal Secretary to Government, Higher Education Department has forwarded the resolutions passed by the 3rd Equivalence Committee held on 12.11.2019 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the non-equivalence of Degrees offered by the Universities / Educational Institutions to the similar Degrees and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, approve the following resolutions passed in the 3rd Equivalence Committee held on 12.11.2019 under the Chairmanship of the Principal Secretary to Government, Higher Education Department and direct that the following Degrees offered by the Universities / Educational Institutions be not equivalent to the Degrees mentioned therein:-

2.11	Public Services – Educational Qualification - Consideration of M.S. Information Technology and Management offered by Bharathidasan University as to whether equivalent to M.Sc. Information Technology for the purpose of employment in Public Services.	Not Equivalent

2.15	Public Services – Educational Qualification - Consideration of M.Sc. Information Science and Management offered by Periyar University as to whether equivalent to M.Sc. Computer Science for the purpose of employment in Public Services.	Not Equivalent

3. The degrees so placed in the Equivalence Committee are however considered as basic degree / post graduate degree, as the case may be, as per University Grants Commission norms.
