PRAYER: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus directing respondents 1 to 6 to consider the proposal submitted by the seventh respondent regarding equivalence of degrees in B1-6/2634/2014 dated 09.04.2015 and consequently, to pass appropriate orders for declaring equivalence of B.Sc. Applied Chemistry with B.Sc. Chemistry by taking an independent decision on merits and consequently, direct the respondents 4 and 5 to promote the petitioner to the post of B.T.Assistant (Science) based on his seniority with retrospective effect on par with juniors with consequential benefits within a time frame to be fixed by this Court.

The relief sought for in the present writ petition is to direct the respondents

1 to 6 to consider the proposal submitted by the seventh respondent regarding equivalence of degrees in B1-6/2634/2014 dated 09.04.2015 and consequently, to pass appropriate orders for declaring equivalence of B.Sc. Applied Chemistry with B.Sc. Chemistry by taking an independent decision on merits and consequently, direct the respondents 4 and 5 to promote the petitioner to the post of B.T.Assistant (Science) based on his seniority with retrospective effect on par with juniors with consequential benefits.

2. The petitioner was selected and appointed to the post of Secondary Grade Teacher on 27.08.1995. The petitioner studied the degree of B.Sc. Applied Chemistry through distance education at Annamalai University and completed the same in the year 2007. Based on the qualification of B.Sc. Applied Chemistry, the petitioner had joined B.Ed. course and completed the same in the year 2011. Thus, the petitioner states that she is fully qualified for promotion to the post of B.T.Assistant. The request, in this regard, made by the petitioner was rejected by the respondents on the ground that the degree of B.Sc. Applied Chemistry from Annamalai University is not equivalent to B.Sc. Chemistry, which is the prescribed qualification for promotion/appointment to the post of

B.T.Assistant Chemistry. Since the equivalence of degrees was not granted by WEB COPY the Government, the petitioner is constrained to move the present writ petition.

3. Learned Special Government Pleader appearing for the respondents 1, 2, 4 and 5 drew the attention of this Court with reference to the equivalence between the degrees *viz.*, B.Sc. Applied Chemistry and B.Sc. Chemistry. The Government rejected the same and held that both the degrees are not equivalent. In this regard, Government issued G.O.Ms.No.172, Higher Education (K2) Department, dated 30.09.2014. Equivalence of Applied Chemistry granted by Annamalai University has been specified below in the said Government Order:

Further, it is stated that pursuant to the directions issued by the Madurai Bench of Madras High Court in the writ petition filed by the petitioner in W.P.No.10481 of 2014, the respondents considered the claim of the petitioner and rejected the same based on the said Government order issued in G.O.Ms.No.172, Higher Education (K2) Department, dated 30.09.2014.

4. When the Government passed an order stating that B.Sc. Applied

Chemistry granted by Annamalai University through distance education is not equivalent to the degree of B.Sc. Chemistry, the petitioner is not entitled for promotion to the post of B.T.Assistant Chemistry. Thus, the decision of the respondents are in consonance with the Government orders in force.

Thus, this Writ Petition is devoid of merits and accordingly, stands dismissed. No costs. Connected miscellaneous petition is closed.
