#### **ORDER:**

In G.O. first read above, the Government have modified the syllabus for the Departmental Examinations for the Pro-Deputy Collectors within their probation period, as follows:-

Paper 2: Law

Paper 3: Revenue

paper 4: History and Culture of Tamil Nadu

paper 5: Financial Management

#### Part II

Paper 7 Finance

- 2. The Tamil Nadu Treasury Code.
- 3. The Tamil Nadu Account, Code.
- 4. The Tamil Nadu Budget Manual.
- 5. Fundamental Rules.

Paper 8 Revenue

## Paper 9 Revenue Survey.

- 1. The Settlement and Resettlement Manuals.
- 2. Standing information for the Tamil Nadu state under the head of Settlement.
- 3. The Survey Manual and the rules for revision of Survey and resurvey.

## Paper 10 Panchayats.

In addition to part I above, they have to pass the following papers:

- 1. Indian Penal Code and Special and Local Criminal Laws. (for pro-Deputy Collectors)
- 2. Criminal Procedure Code. (for Pro Deputy Collectors)
- 3. Law of Evidence (for Pro Deputy Collectors)
- 2. The Bharatiya Nyaya Sanhita (Central Act 45 of 2023), the Bharatiya Nagarik Suraksha Sanhita (Central Act 46 of 2023) and the Bharatiya Sakshya Adhiniyam (Central Act 47 of 2023) replacing the Indian Penal Code (Central Act 45 of 1860), the Code of Criminal Procedure (Central Act 2 of 1974) and the Indian Evidence Act (Central Act 1 of 1872), respectively, have come into force with effect from 01.07.2024 vide Government of India Notification S.O.Nos.850(E), SO.848(E) and S.O.849(E), dated 23.02.2024, respectively.
- 3. The Controller of Examinations, Tamil Nadu Public Service Commission in his letter second read above, has requested the Government to revise the syllabus for the tests in respect to Indian Penal Code and Special and Local Criminal Laws, Criminal Procedure Code and Law of Evidence so as to implement the same in the upcoming Half Yearly Examinations and Language Tests October 2024.
- 4. The Addition Chief Secretary / Commissioner of Revenue Administration (FAC), in her letter third read above has requested the Government to issue necessary amendment to Para 3 of Government order first read above.
- 5. The Government after careful examination, have decided to revise the syllabus for the Test for the Deputy Collectors by incorporating the new enactments in the place of the erstwhile Acts and to issue the following amendment to para 3 of the Government Order first read above:-

## Paper 10 Panchayats.

In addition to Part I above they have to pass the following papers:

- 2. Bharatiya Nagarik Suraksha Sanhita 2023 (for Pro Deputy Collectors)
- 3. Bharatiya Sakshya Adhiniyam 2023 (for Pro Deputy Collectors)

If he/she does not acquire the best qualification within the maximum period of 5 years his/her probation shall be terminated as per the explanation in rule 26(b) (ii) of the General Rules.

Provided that a candidate shall be deemed to have passed examinations in (i) Paper 2-Law Under Part I, (ii) Bharatiya Nyaya Sanhita 2023 (iii) Bharatiya Nagarik Suraksha Sanhita 2023 (iv) Bharatiya Sakshya Adhiniyam 2023 if he/she possesses a degree of Bachelor of Laws or a degree equivalent thereto.

Provided that a candidate shall be deemed to have passed examination in Bharatiya Sakshya Adhiniyam 2023 if he/she possesses a degree of Bachelor of General Laws or a degree equivalent thereto.

The Pro Deputy Collector after completion of training, will be given Divisional charge only if he/she passes the papers in part I and the papers in Bharatiya Nyaya Sanhita 2023, Bharatiya Nagarik Suraksha Sanhita 2023 and Bharatiya Sakshya Adhiniyam 2023 for Pro Deputy Collectors.

Deputy Collectors recruited otherwise than by recruitment by transfer shall pass the papers 2,3,4 and 5 under part I along with the papers namely Bharatiya Nyaya Sanhita 2023, Bharatiya Nagarik Suraksha Sanhita 2023 and Bharatiya Sakshya Adhiniyam 2023 for drawal of first Increment and papers 7,8,9 and 10 under part II for drawal of second and subsequent increments."

#### ORDER:

In the G.O. first read above, instructions regarding departmental examinations to the Assistant Collectors belonging to IAS cadre had been consolidated. In the Government order second read above, a new Division called Division-E in the Higher Standard examination with the subject of Panchayat Acts, Rules and orders was added and books for this examination were prescribed in the syllabus.

- 2. At the suggestion of the Tamil Nadu Public Service Commission, the Government have examined the need for a revision of the syllabus in view of that some of the Acts prescribed for half-yearly examinations both for lower and higher standard for IAS officers in Appendix VI of the IAS Manual Part II were outdated and some had been repealed and a number of new Laws have also been enacted both in Parliament and state legislature.
- The Government after careful examination have decided to modify the scheme of the examination as follows:-
- (i) The maximum marks for all the subjects will be 100 uniformly. The pass marks will also be uniformly 50% except for Tamil, where it shall be 60%.

- (ii) The Lower and Higher standard examinations will be renamed as part I and II respectively for convenience sake.
- (iii) Similarly, Divisions A,B,C and D of the Lower standard be designated as papers 1,2,3 and 4 respectively and Divisions A,B, C,D and E of Higher Standard be designated as papers 5,6,7,8 and 9 respectively.
- 4. The Government have further decided to conduct all the exams with books except for Paper 1; Paper 2 (Law Section A only); Paper 4 (History and Finance) and Paper 5. As such, the Assistant Collectors are permitted to utilise books, notes and commentaries in the examination and the system of the examination will be open book system except for Paper 1; Paper 2 (Law Section A only) for 25 marks; Paper 4 (History and Finance) for 100 marks and Paper 5. Since the intake of outsiders has gone up and also an IAS officer has to spend a good part of his career in Public Sector Undertakings, a paper on Tamil Nadu's history and Socio-cultural legacy and a paper on Financial management have been introduced. The IAS probationers are writing IPC, Cr PC and Evidence Act in the LBSNAA, Mussoorie. As such, the same examinations in the departmental test have been deleted.
- 5. Accordingly the following amendment is issued to paragraph 1,3,4 and 5 in the annexures to the G.O. Press No.3793, Public (Special) Department dated 10.12.55.

### Conditions for a pass

4. An Assistant Collector who has once passed in any one of the above papers according to either part shall not be required to pass it again by the same part; but in order to pass in a paper a candidate shall obtain the minimum marks prescribed for each section provided that an Asst. Collector who at an examination for the part I in paper 3 (Revenue) has obtained 75 marks shall be held without further examination to have passed in paper 7 (Revenue) of the part II.

#### Eligibility for Part-II examination:

5. Subject to the provisions of paragraph 4 above, an Assistant Collector will not be allowed to appear for paper 5 or 7 of Part II until he has passed the corresponding paper 1 or 3 of Part I; nor will he be allowed to appear for papers 6 and 8 of part II until he has undergone the prescribed course of Treasury training and survey and maintenance of Revenue records and Registration training respectively.

- 6. Wherever the word lower standard or higher standard occur in the annexure in paragraphs 1 to 16 of the G.O. first read above, may be read as Part-Lor Part-II respectively. Wherver the word Division A,B,C & D of lower standard or Divisions A,B,C,D & E of higher standard occur in the annexure in paragraphs 1 to 16 of the G.O. first read above may be read as Paper-1,2,3 & 4 of Part-I or Paper-5,6,7,8 & 9 of Part-II respectively.
- 7. In the appendix to the G.O. first read above, syllabus for Divisions B,C & D of the Lower and Higher Standard examinations was prescribed. In the G.O. second read above, syllabus for Division E of the Higher Standard Examination was prescribed. The Government also direct that the following revision of syllabus be made in the appendix to the G.O. first and second read above.
